Sir/Madam,

The recognition was granted by the Northern Regional Committee to Shri Krishna Yogiraj Degree College, Village - Ratibhanpur, Tehsil - Sikandra Road, Mahamaya Nagar, District - Hathras, Uttar Pradesh, PIN -204215 for B.Ed. course vide Order No. NRC/NCTE/ F-3/ UP-604/ 2002/7617-7624 dated 30/09/2002 for B.Ed. course of one year duration with an annual intake of 100 seats from the academic session 2002-2003.

- As per decision of NRC in its 365th (Vol-II) (Blended Mode) Meeting held on 08th & 09th March, 2022 the recognition was withdrawn to the institution for B.Ed. course for an intake of 100 seats from the end of the academic session 2022-2023 vide order No. NRC/NCTE/UP-604/365th Meeting/2022/217855-862 dated 08.04.2022
- The Institution filed W.P.(C) 9423/2020 in the Hon'ble High Court of Delhi. The Hon'ble High Court passed an order dated 27/07/2022. The NRC in its 374th Emergent Meeting (Virtual) held on 24th August 2022 considered the Court Order dated 08.08.2022 and the Committee decided as under:

The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC in compliance of orders dated 27/07/2022 passed by the Hon'ble High Court of Delhi in WP (C) 9423/2020 giving the following directions:

"The prayer made by Mr. Manish is what has already been stated in the latest withdrawal order dated 11/04/2022. Accordingly, the present petition is disposed of with liberty to petitioner college to impugn the withdrawal order dated 11/04/2022 under section 18 of the NCTE Act. Needless to say, that in terms of Section 17(1) of the NCTE Act, the said withdrawal order will come into effect from the end of academic session 2022-2023. With the above directions, the present petition is disposed of along with other pending application(s). All rights and contentions of the parties qua grounds urged for withdrawal are left open, respondents shall issue consequential directions in the affiliating university and update the status of petitioner college on their portal".

The recognition of the institution was withdrawn from the end of the academic session 2022-2023 vide withdrawal order dated 08/04/2022.

Hence, the NRC decided to update the website reflecting the status of the institution and communique regarding implementation of withdrawal order be issued.

The affiliating University/ State Govt. may accordingly be intimated.

- In view of the above decision of NRC, it is clarified that the effective session of withdrawal order dated 08.04.2022 issued to Shri Krishna Yogiraj Degree College, Village Ratibhanpur, Tehsil Sikandra Road, Mahamaya Nagar, District Hathras, Uttar Pradesh, PIN -204215. for B.Ed. course would take effect from the end of the academic session 2022-2023.
- Other contents of the order No. NRC/NCTE/UP-604/365th Meeting/ 2022/ 217855-862 dated 08.04.2022 shall remain unchanged.
