WHEREAS, the recognition was granted to the institution, namely Sukdeo Singh Degree College, Village/Post- Baberu, District - Banda - 210121, Uttar Pradesh Village+Post office- Baberu, District- Banda-210121, Uttar Pradesh for conducting B.Ed. course of one year duration with an annual intake of 100 students vide order No. NRC/NCTE/F-3/UP-1582/2005/7400 dated 29.07.2005 followed by revised recognition for B.Ed. course of two year duration with an annual intake of 100 students i.e. two basic units of 50 students each vide order No. NRC/NCTE/UP-1582/2015/105838-43 dated 27.05.2015.

- AND WHEREAS, the name of the institution was changed from Sukhdeo Singh Degree Collage to Sukdeo Singh Lavkush Mahavidyalaya, Village + Post office- Baberu, District- Banda-210121 Uttar Pradesh vide order dated 12.04.2023.
- AND WHEREAS, as per decision of NRC in its 411th meeting held on 15th September, 2023, recognition for B.Ed. course was withdrawn from the academic session 2024-2025 vide order dated 11.10.2023.
- AND WHEREAS, the institution filed an appeal before NCTE (HQ) under section 18 of NCTE Act, 1993 against withdrawal order dated 11/10/2023. The Appellate authority passed an Order dated 10/11/2023 remanding the case back to NRC.
- AND WHEREAS, the institution submitted a reply letter 23.11.2024. which was placed before NRC in its 428th meeting and the Committee decided to issue show cause notice on the following grounds:-
- The institution submitted a colored photocopy of the approved staff list. The institution is required to submit original faculty list duly approved by the affiliating university.
- The institution has not submitted the letter from the affiliating body for approval of the faculty
- One month salary statement of the faculty member with details of the account number be forwarded for verification.
- The institution has not submitted the original certified copy of the land documents.
- AND WHEREAS, show cause notice was issued to the institution 24.10.2024. The institution has submitted a reply of show cause notice vide letter dated 05.11.2024.
- 7. AND WHEREAS, the matter was placed before NRC in its 431st meeting held on 09th to 11th December, 2024, and the Committee decided as under:-

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution namely Sukdeo Singh Lavkush Degree College, Village + Post Office -Baberu, District Banda- 210121, Uttar Pradesh for B.Ed. course of one year duration with an annual intake of 100 students vide order dated 29/07/2015 and revised recognition order was issued to the institution for B.Ed. course of two-year duration with an annual intake of 100 seats (two units) vide order dated 27/05/2015.
- The name of the institution was changed from Sukhdeo Singh Degree College to Sukdeo Singh Lavkush Mahavidyalaya, Village + Post Office -Baberu, District Banda- 210121, Uttar Pradesh vide order dated 12.04.2023.
- As per decision of NRC in its 411<sup>th</sup> meeting, recognition for B.Ed. course was withdrawn from the academic session 2024-2025 vide order dated 11.10.2023
- The institution filed an appeal to NCTE Hqrs. under Section 18 of NCTE Act, 1993 against withdrawal Order dated 11/10/2023. The Appellate authority passed an Order dated 10/11/2023 remanding the case back to NRC with a direction to verify the faculty list submitted in appeal from the concerned affiliating university and also at liberty to verify other documents from the concerned competent authority. The appellant institution was directed to forward to NRC the documents submitted in appeal within 15 days from the receipt of order the Appeal.
- The institution submitted a reply vide letter 23.11. 2024. The reply of the institution was placed before NRC in its 428<sup>th</sup> meeting and the Committee decided to issue show cause notice. Accordingly, show cause notice was issued to the institution 24.10.2024. The institution has submitted a reply of show cause notice vide letter dated 05.11.2024.
- The reply submitted by the institution against the first show cause notice dated 24.10.2024 has been considered by the NRC and the same has been found satisfactory.

Hence, the Committee decided to issue Continuation Order for B.Ed. course of two years duration with an annual intake of 100 students (two units each of 50).

- **8. NOW THEREFORE, in terms of above decision of NRC**, the recognition granted to the institution namely **Sukdeo Singh Lavkush Degree College**, Village+Post office- Baberu, District-Banda-210121, Uttar Pradesh is hereby continued for **B.Ed.** course of two year duration with an annual intake of 100 students i.e. two units of 50 students each.
- 9. If the institution contravenes any of the provisions of the NCTE Act, Rules, Regulations and orders issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
