Accordingly, as per the decision of NRC in its 118th (2nd sitting), the name of the institution i.e. HARVARD INSTITUTE OF MANAGEMENT & TECHNOLOGY be read as HARLAL INSTITUTE OF MANAGEMENT AND TECHNOLOGY.

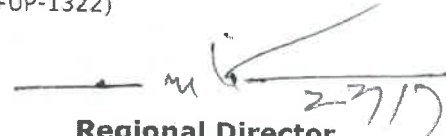
