#### CORRIGENDUM ORDER

7 17 JUL 2023

The institution namely **Vindhya Gurukul College, Plot No.-9, Street No.-00, Village-9, Post office-Chunar, Tehsil/Taluka-Chunar, District-Mirzapur, State-Uttar Pradesh-231304** was granted Recognition for B.Ed. course two years duration with an annual intake of 50 students (01 unit) vide NRC order No. NRC/NCTE/NRCAPP- 15386/266<sup>th</sup> Meeting (Part-2)/B.Ed./2017/171403-09 dated 17.04.2017

2. The institution has submitted a representation dated 08.07.2023. The matter was placed in its NRC  $403^{rd}$  meeting (online mode) held on  $13^{th}$  &  $14^{th}$  July, 2023 and the committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The institution has submitted representation dated 8/7/2023 requesting to issue a letter in respect of decision taken by NRC in its 270<sup>th</sup> meeting held on 29-30 May 2017.

The NRC noted that the NRC in its 270<sup>th</sup> meeting held on 29<sup>th</sup>-30<sup>th</sup> May 2017 has decided as under:-

"The number of seats mentioned in the decision taken in 266th meeting (Part 2) at Sr. No. 03 be read as One hundred in place of Fifty. Correction be made accordingly."

As per the records of NRC, the decision of NRC taken in 270<sup>th</sup> meeting has not been implemented till date.

NRC considered the above facts and representation of the institution and decided to issue corrigendum order as per decision taken by NRC in 270th meeting of NRC".

3. In light of the above decision of NRC the seats mentioned in the recognition order No. File no. NRC/NCTE/ NRCAPP- 15386/266<sup>th</sup> meeting (Part-2)/B.Ed./2017/171403-09 dated 17.04.2017 be read as 100 seats (two units) in place of 50 seats (one unit).

The other contents of the order shall remain unchanged.
