(4 year Integrated) and B.Ed. courses/B.Ed. colleges can be entertained for the academic session 2018-2019-2020 and 2020-2021-2022 respectively.

The Committee carefully examined the matter and is of the opinion that the detailed scrutiny of application of the institution is required. The institution is directed not to admit students for the academic session 2020-2021 till conclusion of the scrutiny of the file and decision of NRC.
