## WITHDRAWAL ORDER

16 MAY 2023

WHEREAS, the recognition was granted to the institution namely College of Applied Education & Health Sciences, Plot Number- A-122, Gangotri Colony, Village/Town- Meerut, Post Office- Krishna Nagar, Roorkee Road, Meerut, Tehsil/Taluka-Sardhana, Town/City- Sardhana, District- Meerut - 250001, State- Uttar Pradesh for conducting D.El.Ed. course of two-years duration with an annual intake of 50 students vide Order No. NRC/NCTE/234<sup>th</sup> Meeting/NRCAPP-5180/92948-953 dated 10.04.2015.

- 2. **AND WHEREAS**, complaint against the institution has been received from Dr. Ajay Kumar, A-109, Gangothri Colony, Rudaki Road, Meerut, Uttar Pradesh addressed to NCTE Hqrs. The matter was considered by NRC in its 289<sup>th</sup> Meeting held on 08<sup>th</sup> to 09<sup>th</sup> October, 2018 and Committee decided as under:-
  - Complaint be forwarded to the institution for obtaining comments.

Accordingly, letter was issued to the institution on 23.10.2018

- 3. AND WHEREAS, the institution has not submitted reply of letter dt. 23.10.2018. The matter was considered by NRC in its 306<sup>th</sup> Meeting held on 28<sup>th</sup> to 30<sup>th</sup> august, 2019 and Committee decided as under :-
  - A reminder to be sent to the institution in connection with NRC letter dated 23.10.2018 with a direction to submit appropriate point wise reply within 30 days.

Accordingly, reminder to Complaint was forwarded letter to the institution on 13.09.2019.

- 4. AND WHEREAS, The institution has submitted reply in NRC office on 11.10.2019. The matter was considered by NRC in its 327<sup>th</sup> Meeting (Virtual) held on 08<sup>th</sup> & 10<sup>th</sup> February, 2021 and Committee decided as under :-
  - Points-wise comments of institution may be obtained on the complaint within 30 days.

Hence, a letter be issued to the institution accordingly.

Accordingly, letter was issued to the institution on 23.02.2021

5. AND WHEREAS, The institution has not submitted reply the matter was considered by NRC in its 398<sup>th</sup> meeting (Blended Mode) held on 09<sup>th</sup> & 10<sup>th</sup> May, 2023 and the committee decided as under:

1. As per decision of NRC in its 288<sup>th</sup> Meeting held on 5<sup>th</sup> to 7<sup>th</sup> September, 2018, the recognition of B.Ed course was withdrawn on the basis of complaint 26.09.2017 received from the Secretary, Meerut Development Authority clearly stated that the documents dated 02/07/2008 & 22/04/2009 submitted by institution were not issued by the Meerut Development Authority.

2. It is observed that the D.El.Ed programme was also granted recognition with annual intake of 50 students on the same land and building on 10.04.2015

Keeping in view the above, the NRC decided that the recognition/ permission of the institution granted for D.El.Ed programme (50 seats) be withdrawn from the academic session 2023-24.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of College of Applied Education & Health Sciences, Plot Number- A-122, Gangotri Colony, Village/Town- Meerut, Post Office- Krishna Nagar, Roorkee Road, Meerut, Tehsil/Taluka-Sardhana, Town/City- Sardhana, District- Meerut - 250001, State- Uttar Pradesh granted for D.El.Ed. course for an intake of 50 Seats (one unit) vide order dated 10.04.2015 on the grounds mentioned above from the academic session 2023-2024.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order.
