ORDER FOR WITHDRAWAL OF RECOGNITION

AND WHEREAS, The institution has submitted a representation dated 04/04/2023 requesting to closure of institution having B.Ed. course along with affidavit Rs. 100 stamp paper and resolution of the society.

AND WHEREAS, the matter was placed before NRC in its 397th (Online Mode) meeting held on 18th & 19th April 2023 and the Committee decided as under:

" The representation of the institution dated 04/04/2023 was considered by NRC and decided to close/withdraw the recognition of the B.Ed. Course granted to the institution. Therefore, the institution and all the concerned be informed accordingly "

NOW THEREFORE, in view of the above decision the NRC hereby withdraw the recognition granted to the institution namely Sky Institute of Management and Technology , Plot Number- 272, Street /Road- Jaipur Road, Village/Town/ City- Ladamda, Post Office- Bichpuri, Tehsil/Taluka- Sadar, Town/City- Agra, District- Agra, State- Uttar Pradesh, Pin Code - 283105 for B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-2016 vide order No. File No. NRC/NCTE/NRCAPP7124/238 meeting part V/108941-64 dated 03/05/2015
