RESTORATION ORDER

1 2 AUG 2024

WHEREAS the recognition was granted to the institution viz. Doon Valley Institute of Education, Outside Jundla Gate, Karnal-132001, Haryana for conducting B.Ed. Course with an annual intake of 100 from the academic session 2004-2005 vide order No. NRC/NCTE/F-3/HR-183/5883-5891 dated 16.08.2024 and for additional intake in the existing B.Ed. Programme with annual intake of 300 (100+200) students vide order No. NRC/NCTE/F-3/HR-409/6254-6263 dated 29.09.2006.

- 2. AND WHEREAS, the revised recognition was granted to the institution for conducting **B.Ed.** programme of two years duration with an annual intake of 300 for (six basic units of 50 students each) from the academic session 2015-2016 vide order No. NRC/NCTE/HR-183 & HR-409/2015/120823-829 dated 13.08.2015 with the condition of adherence of provisions of NCTE Regulations, 2014.
- 3. AND WHEREAS, the institution filed a writ petition W.P. (C) 1679/2023 before the Hon'ble High Court of Delhi.
- 4. **AND WHEREAS,** the matter was placed before the NRC in its 395th meeting held on 2nd and 3rd March 2023. The original file of the institution along with other related documents, NCTE Act 1993, Regulations and guidelines issued by NCTE from time to time were carefully considered by NRC in light of order dated 27/02/2023 passed in W.P.(C) 1679/2023 and NRC decided to issue Show Cause Notice u/s 17 of the NCTE Act.1993. Accordingly, Show Cause Notice was issued to the institution on 21.03.2023.
- 5. AND WHEREAS, the matter was placed before the NRC in its 401st meeting held on 27th June 2023 and committee decided as under:

The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

- 1. The recognition was granted to the institution namely Doon Valley Institute of Education, Outside Jundla Gate, Karnal, Haryana run by Doon Valley Trust for B.Ed. course of one year duration with an annual intake of 100 students vide order dated 16.08.2004 and additional intake of one year duration with an annual intake of 200 students vide order dated 29.09.2006 and revised order was issued to the institution of two year duration an annual intake of six basic unit of 50 each (300 students)
- 2. The matter was considered in light of W.P. (C) No.1679/2023 by NRC in its 395th meeting held on 2nd & 3rd March 2023 and the committee decided to issue SCN to the institution on the following grounds:
 - i. The Doon Valley Trust is required to send original application seeking recognition along with name of the institution, place, intake mentioned in the original application.
 - ii. The Doon Valley Trust is to submit certified copy of Registered Deed of trust along with names of the trustees and their present position.
 - iii. The Doon valley trust is required to submit the place permitted to run the institution along with intake.
 - iv. The Doon Valley Trust is required to submit the affiliation letter issued to it.
 - v. The Doon Valley Trust is required to submit the application made for incorporation of trust into company under section 25 of the Companies Act, 1956.
 - vi. The Doon Valley Trust is required to submit the certificate of incorporation along with names of its directors and name of the institution run by the company Doon Valley Trust.
 - vii. The Doon valley trust is required to tell the present status of the earlier Trust namely Doon Valley Trust.
 - viii. The Doon Valley Trust is required to submit the compromise deed dated 13.11.2018 executed between its directors.
 - ix. The Doon Valley Trust is required to submit the details of website maintained by the institution.
- 3. Accordingly, SCN was issued to the institution on 21.03.2023. The institution has submitted reply on 08.05.2023. The matter was considered b NRC and the Committee observed the following:
 - The institution has not submitted original application seeking recognition along with name of the institution, place and intake mentioned in the original application.
 - In reply to point no.5 of the SCN the Doon Valley Trust on 18.04.2011 has submitted an application for seeking incorporation as a company under section 25 of the Companies Act, 1956.
 - In reply to point no.6 the Doon Valley Trust has submitted the certificate of incorporation as well as the name of the Director of the said company.
 - It is observed that the Doon Valley Trust which was earlier at the time of recognition registered under the societies registration Act has now been incorporated as a company under companies Act., 1956 which is not permissible under the NCTE Regulations.

Hence, the NRC decided that Second Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issue to the institution to submit the reply within 7 days from the date of issue of Show Cause Notice.

Accordingly, Final Show Cause Notice was issued to the institution on 26.07.2023 and institution has submitted reply of Final Show Cause Notice vide letter dated 21.08.2023 and received in NRC office on 26.08.2023.

6. AND WHEREAS, the above mentioned reply of Final Show Cause Notice dated 26.07.2023 was considered by NRC in its 410th meeting held on 04th & 05th September 2023 and committee decided as under:

The original file of the institution along with the related documents, NCTE Act. 1995, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the committee observed following:

As per decision of NRC in its 401st meeting Final SCN was issued to the institution on 26/07/2023. The institution has submitted reply of Final SCN vide letter dated 26.08.2023. The matter considered in NRC and the committee observed the following:

- The Doon Valley Institution of Education, outside Jundla Gate, Karnal, Haryana running under the trust namely Doon Valley Trust was granted recognition by NRC vide order dated 29/09/2006.
- The submission of reply by Doon Valley Trust clearly implies that the trust of the institution has been changed as company under section 25 of the companies Act., 1956.
- It is clear that the Doon Valley Trust which was earlier at the time of recognition registered under the societies registration Act., has now been incorporated as a company under Companies Act.1956 which is not permissible under the NCTE Regulations 2014.

In view of the above observations the committee decided to withdraw the recognition granted to Doon Valley Institute of Education, Outside Jundla Gate, Karnal, Haryana – 132 001 for B.Ed. and B.Ed. additional intake under section 17 of the NCTE Act., 1993 from the academic session 2024-2025.

Accordingly, Withdrawal Order was issued to the institution on 15/Sep/2023.

7. AND WHEREAS, the institution filed W.P (C) 6277/2024 in the Hon'ble High Court of Delhi at New Delhi. The Hon'ble Court passed an order on 10.05.2024. The operative part of court order is as under: -

"Accordingly, the impugned order dated 15 September 2023 withdrawing the recognition of the petitioner institution and the order dated 12 April 2024 whereby the said withdrawal has been upheld in appeal by the Appellate Committee are quashed and set aside.

The Petitioner's recognition shall stand restored.

The Respondent NCTE is therefore directed.

- i) To issue a formal order of restoring the recognition of the petitioner institution,
- ii) Correct the status of the petitioner institution on its website and inform the affiliating body of the petitioner regarding the decision taken today, within a period of two weeks."
- 8. AND WHEREAS, the matter was placed before NRC in its 421st meeting held on 21st & 22nd, May 2024 and committee decided as under:

The regulatory file of the institution, order dated 10.05.2024 in W.P. (C) No. 6277/2024 passed by the Hon'ble High Court of Delhi alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by NRC.

• The Hon'ble Court directed as follows:

"The Respondent NCTE is therefore, directed

- (i) to issue a formal order of restoring the recognition of the petitioner institution,
- (ii) correct the status of the petitioner institution on its website and
- (iii) inform the affiliating body of the petitioner regarding the decision taken today, within a period of two weeks."

The copy of the order dated 10.05.2024 was received in the office of NCTE on 21.05.2024 and accordingly the committee decided:

• The committee decided to file appeal/LPA against the order dated 10.05.2024.

Letter/Order be issued accordingly.

9. AND WHEREAS, in pursuance of the decision taken by the Committee in 421st meeting an LPA Bearing no. 615/2024 titled as "National Council for teacher Education & Anr. Vs Doon Valley Institute of Education" was filed and was listed on 19.07.2024 before the Division Bench in Delhi High Court.

The Hon'ble High Court Vide order dated 19.07.2024 dismissed the said LPA and directed as follows:

"In view of the aforesaid analysis and findings, we find no reason, much less any cogent reason to interfere with the impugned judgment passed by the learned Single Judge. Resultantly, the present appeal is dismissed without any order as to costs.

Pending applications also stand disposed of.

Since the time given to the appellants for the implementation of the impugned judgment by the learned Single Judge has expired, we deem it fit to extend the same by another two weeks to implement the directions contained in the impugned judgment dated 10th May 2024."

9. AND WHEREAS, matter was placed before NRC in its 424th (Emergent) meeting of NRC held on 01st August 2024 and Committee decided as under:

The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

• In pursuance to the Order dated 19.07.2024 passed by the Hon'ble High Court of Delhi in LPA 615/2024 & C.M. APPL. 40091-93/2024, the committee decided to restore recognition of the institution for running B.Ed. course until a fresh withdrawal order is passed by the NRC as per NCTE Regulations 2014.

Order be issued accordingly to all concerned.

NOW THEREFORE, in view of the above decision of NRC, the NRC hereby restores the recognition to the institution namely **Doon** Valley Institute of Education, Outside Jundla Gate, Karnal – 132001, Haryana for B.Ed. course with an annual intake of 300 students until a fresh withdrawal order is passed by the NRC as per NCTE Regulations 2014.
