## **ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Rehbar Institute of Education, Plot/Khasra No.- 15, 17, 16, 23, 22, Street/Road-NH-64, Village -Rampura, Post Office - Bhawanigarh, Tehsil/Taluka- Bhawanigarh, Town/City- Bhawanigarh, District- Sangrur, Punjab - 148026 was granted recognition for conducting **B.Ed.** programme of two year duration with an annual intake 100 seats (two basic units) vide recognition Order No. F.No.NRC/NCTE/NRCAPP-2649/238th (4th Sitting) Meeting/2015/108851-55 dated 31.05.2015 from the academic session 2015-2016, as per NCTE Regulations. 2014.

AND WHEREAS, the matter was placed before NRC in its 414th Meeting held on 06th & 07th October, 2023 and the Committee decided as under: -

Consideration of C.W.P. 17369/2023 with CWP-16241/2022 titled as Syon Educational and Welfare society and Anr vs State of Punjab and other.

The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee noted the following:

The Hon'ble High Court of Punjab and Haryana vide order dated 29/08/2023 made a observation that the NRC, NCTE is granting conditional recognition to the institute in the State of Punjab and Haryana in derogation of directions issued by Hon'ble Supreme Court of India in case titled as Adarsh Shiksha Mahavidyalaya Vs Subhash Rehangdale and Anr.

That vide order dated 03/10/2023 the Regional Director, NRC appear before the Hon'ble Court and made a statement that he would ensure the compliance the directions issued by Hon'ble Supreme Court of India and constitute inspection of colleges on urgent basis.

The NRC after perusal of directions of Hon'ble Court decided to recommend NCTE Hgrs. to conduct the inspection of following TEIs on u/s 13 of NCTE Act, 1993 and provide the report to NRC.

AND WHEREAS, an e-mail dated 20.10.2023 received through Inspection Section from Rehbar Education rehbareducation@gmail.com on 18.11.2023 requesting the following:-

As per your mail on dated 20.10.2023 regarding the virtual/online inspection of Rehbar Institute of Education, Bhawanigarh, District - Sangrur (Punjab). Regarding the matter, we hereby inform to you that the previous two consecutive sessions we have no admission in B.Ed. course due to this reason we have decided to close the B.Ed. course in future. About this matter we have already inform you through the mail to the NCTE authorities about the postponement of

our college inspection. We have already shared this information to NCTE authorities. About this we are highly regrettable for your inconvenience.

**4. AND WHEREAS,** the matter was placed before NRC in its 416th Meeting held on 20th December, 2023 and the Committee decided as under: -

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP and guidelines issued from time to time were placed before the Northern Regional Committee. The NRC made the following <u>observations</u>: -

The NRC considered the request of the institution made vide e-mail dated 20.10.2023 and directed that the institution be required to submit the following within a period of 15 days –

- 1. Resolution of the society / trust regarding closure / withdrawal of the course duly signed by all members of the society / trust.
- 2. NOC of the affiliating body for closure / withdrawal of the course.
- 3. Formal request for closure / withdrawal of the course on the Affidavit of Rs. 100/- duly signed by the authorized representative of the management.

Accordingly, First Show Cause Notice issued on 19.01.2024. and Reply from the institution received on 08.02.2024 & 25.04.2024

- **5. AND WHEREAS,** the matter placed before ERC in its Minutes of 422<sup>nd</sup> (Part-2) Meeting of NRC held on 06th and 07th June, 2024 and The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.
- The Committee considered the representation dated 08.02.2024 & 02.04.2024 submitted by the institution requesting to close the institution for running B.Ed. course and the Committee decided to agree to close the institution as requested by the institution by withdrawing the recognition granted to Rehbar Institute of Education, Plot/Khasra No.- 15, 17, 16, 23, 22, Street/Road- NH-64, Village -Rampura, Tehsil/Taluka- Bhawanigarh, District- Sangrur, Punjab 148026 for conducting B.Ed. course under clause 17(1) of NCTE Act, 1993 with immediate effect.

Order be issued accordingly and the FDRs may also be returned.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Rehbar Institute of Education, Plot/Khasra No.- 15, 17, 16, 23, 22, Street/Road- NH-64, Village Rampura, Post Office Bhawanigarh, Tehsil/Taluka- Bhawanigarh, Town/City- Bhawanigarh, District-Sangrur, Punjab 148026 for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units).
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
