WITHDRAWAL ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Shri Kirori Lal Shastri Mahavidyalaya, Jagner, District - Agra, State - Uttar Pradesh vide Order No. NRC/NCTE/F-7/UP-2024/148th Meeting/2009/9710-9716 dated 31.08.2009 with an annual intake of 100 seats from the academic session 2009-10. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-2024/2015/145126-31 dated 08.04.2016 for B.Ed. course of two years duration with an annual intake of two units of 50 students each was issued to the institution with certain conditions.

- 2. AND, WHEREAS, Dr. B. R. A. University, Agra, stated in their letter No.7998/2019 dated 19.01.2019 that एन०सी०टी०ई० द्वारा बी०एड० पाद्यकम संचालन हेत् विनियमन 2014 लागू किया गया है उक्त विनियमन के प्रावधान के अनुसार आपके महाविद्यालय में बी०एड० पाठयकम में छात्रों के पठन पाठन हेत् एक यूनिट (50 छात्र) पर ०८०३ (विशिष्ट विषय शिक्षक –फाईन आर्ट, संगीत एवं शारीरिक शिक्षा-) 11 तथा दो यूनिट (१०० छात्र) पर १६ शिक्षकों का अनुमोदन विश्वविद्यालय से प्राप्त करना चाहिये था, किन्तु विनियमन लागू होने क 04 वर्ष बाद भी आपके महाविद्यालय द्वारा न तो कोर—फैकल्टी और नही विशष्ट विषयों यथा 7 फाईन आर्ट, संगीत, शारीरिक शिक्षा हेतु शिक्षक अनुमोदित कराये गये हैं जो कि विनियमन 2014 के अनुसार नियम विरुद्ध है साथ ही माननीय कुलपति जी के दिनांक 16.11. 2017 के आदेशानुशार महाविद्यालय में पूर्व से कार्यरत शिक्षको का अनुमोदन 05 वर्ष पूर्ण होने पर शासनादेश संख्या 2218 / सत्तर—2--2011—16(409) / 2010 दिनांक 23.08.2011 के अनुपालन में विश्वदिप्तालय से पुनः अनुमोदन निरस्त कर दिया गया है। इस संबंध में सभी महाविद्यालयों की लॉगिन पर विश्वविद्यालय के पत्रांक संख्या संब / 4213 / 2017 दिनांक 17.11. 2017 के हारा सूबना अपलोड की गयी थी तथा विश्वविद्यालय हारा पूनः एक पत्र संख्या संब / 4361 / 2017 दिनांक 15.12. 2017 के द्वारा भी आपके महाविद्यालय में संचालित स्थायी बी०एड0 पाट्यकम से संबंधित विभिन्न वॉछित सूचनायें उपलब्ध कराने हेतु महाविद्यालय की लॉगिन पर सूचना अपलोड करायी गयी थी। परन्तु आपके द्वारा उपरोक्त पत्रों के सापेक्ष में किसी तरह की सूचना आजतक उपलब्ध नहीं करायी गयी, जो कि संबद्धता शर्तों का उलंघन है। ऐसा प्रतीत होता है कि महाविद्यालय प्रबन्धन / प्रशासन उपरोकत पाठ्यक्रम को संचालित करने में रुचि नहीं ले रहा है।
- AND, WHEREAS, as per decision of the NRC in its 301st Meeting held on 09th to 11th 3. May, 2019, a show cause notice u/s 17 was issued on the institution on 02.07.2019 seeking their comments on the complaint raised by the affiliating university.
- AND WHEREAS, the institution has submitted reply in NRC office on 28.08.2019. The matter was considered by the Northern Regional Committee in its 310th Meeting held on 20th to 22nd November, 2019 and the Committee observed the following: -

The institution has not submitted approved faculty list in original with the details of their academic qualifications/ experience etc.

- The institution has not submitted the details of salary disbursed to the faculty along with six months Bank statement along with account number of each faculty members.
- The reply of SCN dated 02.07.2019 submitted by the institution is not satisfactory as it
 does not address the above deficiencies and the institution is being given final
 opportunity before withdrawal of recognition.
- Further, the website link showing the faculty details is not submitted by the institution.

Accordingly, Second Show Cause Notice U/S 17 (Complaint) was forwarded letter to the institution on 26.12.2019.

- 5. **AND, WHEREAS,** the institution did not submit any reply in NRC office till date. The matter was considered by the NRC in its 312th (Emergent) Meeting held from 14th February, 2020 and the Committee decided as under: -
 - As per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition of the institution may be withdrawn as enough opportunities have been given to the institution.

Hence, NRC decided to withdraw the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. A detailed withdrawal order be issued to the college.

6. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of Shri Kirori Lal Shastri Mahavidyalaya, Jagner, District – Agra, State – Uttar Pradesh granted for B.Ed. course for an intake of 100 seats on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.
