WITHDRAWAL ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Raja Devi Degree College, Plot/Khasra No. – 164 & 166, Street No. – NA, Village/Town – Badokhar Khurd, Post Office – Banda, Tehsil/Faluka – Banda, Town City – NA, District – Banda, Pin Code – 210001, State – Uttar Pradesh vide Order No. NRC/NCTE/F-7/UP-3156/150th Meeting/2009/11754-11760 dated 29.10.2009 for B.Ed. course of one year duration with an annual intake of 100 seats. In light of NCTE Regulations, 2014, Revised Recognition Order No. NRC/NCTE/UP-Common Orders/2015/114788-114811 dated 07.06.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 student each was issued to the institution with certain conditions.

2. AND WHEREAS, as per the decision of the Northern Regional Committee in its 281st Meeting, a Show Cause Notice u/s 17 was issued on 05.04.2018 to the institution on following grounds with a direction to submit the reply to Show Cause Notice within 21 days from the date of issue of SCN.

- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- The institution should have already identified/selected the faculty/staff by 29th February, 2016 for which the approval from the affiliating body for the same be submitted to this office immediately.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

3. AND WHEREAS, the institution has submitted reply in NRC Office on 08.05.2018. The matter was considered by the Northern Regional Committee in its 308th Meeting held on 25th to 27th September, 2019 and the Committee observed the following:-

Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the following observation was made:-

1. The institution has not submitted Form "A".
2. The institution has submitted teaching faculty approved by Bundelkhand University, Jhansi, Uttar Pradesh vide dated 12.03.2010, 09.11.2009, 05.11.2011, 13.09.2013 and 03.12.2013 which is not qualified as per NCTE Regulations, 2014.

Hence, show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice."

Accordingly, Second Show Cause Notice U/S 17 was issued to the institution on 15.10.2019.

4. AND, WHEREAS, the institution has submitted reply in NRC Office on 21.10.2019 & 18.11.2019. The matter was considered by the NRC in its 315th (Virtual) Meeting held from 17th to 20th August, 2020 and the Committee decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the Committee made following observations:-

Second show cause notice was issued to the institution on 15.10.2019. The institution submitted reply of the show cause notice in NRC office on 21.10.2019 & 18.11.2019. The reply submitted by the institution has still following deficiencies:-

1. The latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D.(NCTE's GOI dated 09.06.2017), salary structure and related documents, duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma are not submitted. Approved faculty list is not submitted as per Appendix- 4 of NCTE Regulation, 2014 (Amended from time to time).
2. Downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014 not submitted.

Hence, NRC decided to withdraw the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of communication of withdrawal order. A detailed withdrawal order be issued to the institution.

The Committee decided to put up M.Ed. file no. NRCAPP-14333 of this institution in the next meeting for consideration under RRO."



5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of **Raja Devi Degree College, Plot/Khasra No. – 164 & 166, Street No. – NA, Village/Town – Badokhar Khurd, Post Office – Banda, Tehsil/Taluka – Banda, Town City – NA, District – Banda, Pin Code – 210001, State – Uttar Pradesh** granted for **B.Ed.** course for an intake of 100 Seats (two units of 50 student each) vide order dated 29.10.2009 & Revised Recognition order dated 07.06.2015 on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.
