WITHDRAWAL ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to **Krishna Girls Academy, Plot No. – 313, Village – Laramda, Post Office – Bichpuri, Tehsil - Sadar, District – Agra, State – Uttar Pradesh** vide Order No.NRC/NCTE/F-7/UP-3517/EM/2010/28009-28014 dated 23.09.2010 with an annual intake of 100 seats from the academic session 2010-11. In light of NCTE Regulations, 2014, Revised Recognition Order No.NRC/NCTE/UP-Common Orders/2015/115484-516 dated 09.06.2015 for B.Ed. course of two years duration with an annual intake of 100 (two units of 50 students each) was issued to the institution with certain conditions.

2. **AND WHEREAS**, as per the decision of the Northern Regional Committee in its 281<sup>st</sup> Meeting, a Show Cause Notice u/s 17 was issued on 05.04.2018 to the institution on following grounds with a direction to submit the reply to Show Cause Notice within 21 days from the date of issue of SCN:-

- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- The institution should have already identified/selected the faculty/staff by 29th February, 2016 for which the approval from the affiliating body for the same be submitted to this office immediately.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to-SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

3. **AND WHEREAS**, Dr. B. R. A. University, Agra, stated in their letter No.पत्रांक:-सम्ब0/8012/2019 दिनांक 19.01.2019 that एन0सी0टी0ई0 द्वारा बी0एड0 पाठ्यक्रम संचालन हेतु विनियमन 2014 लागू किया गया है उक्त विनियमन के प्रावधान के अनुसार आपके महाविद्यालय में बी0एड0 पाठ्यक्रम में छात्रों को पाठन पाठन हेतु एक यूनिट (50 छात्र) पर 0803 (विशिष्ट विषय शिक्षक -फाईन आर्ट, संगीत एवं शारीरिक शिक्षा) 11 यूनिट (100 छात्र) पर 16 शिक्षकों का अनुमोदन विश्वविद्यालय से प्राप्त करना चाहिये था, किन्तु विनियमन लागू होने के 04 वर्ष बाद भी आपके महाविद्यालय द्वारा न तो कोर-फैकल्टी और नही विशिष्ट विषयों यथा 7 फाईन आर्ट, संगीत, शारीरिक शिक्षा हेतु शिक्षक अनुमोदित कराये गये है जो कि विनियमन 2014 के अनुसार नियम विरुद्ध है साथ ही कानूनन कुलपति जी के दिनांक 16.11.2017 के आदेशानुसार महाविद्यालय में पूर्व से कार्यरत शिक्षकों का अनुमोदन 05 वर्ष पूर्ण होने पर शासनादेश संख्या 2218/सत्तर-2-2011-16(409)/2010 दिनांक 23.08.2011 के अनुपालन में विश्वविद्यालय से पुनः अनुमोदन निरस्त कर दिया गया है। इस संबंध में सभी महाविद्यालयों की लॉगिन पर विश्वविद्यालय के पत्रांक संख्या गव/4213/2017 दिनांक 17.11.2017 के द्वारा सूचना अपलोड की गयी थी तथा विश्वविद्यालय द्वारा पुनः एक पत्र संख्या गव/4361/2017 दिनांक 15.12.2017 के द्वारा भी आपके महाविद्यालय में संचालित स्थायी बी0एड0 पाठ्यक्रम से संबंधित विभिन्न वैधित सूचनायें उपलब्ध कराने हेतु महाविद्यालय की लॉगिन पर सूचना अपलोड करायी गयी थी। परन्तु आपके द्वारा उपरोक्त पत्रों के सापेक्ष में किसी तरह की सूचना आज तक उपलब्ध नहीं करायी गयी, जो कि संवैधानिक शर्तों का उल्लंघन है। ऐसा प्रतीत होता है कि महाविद्यालय प्रबंधन/प्रशासन उपरोक्त पाठ्यक्रम को संचालित करने में रुचि नहीं ले रहा है।

4. **AND WHEREAS**, as per decision of the NRC in its 301<sup>st</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> May, 2019, a second show cause notice u/s 17 was issued to the institution on 19.06.2019 on the following grounds:-

- The committee decided to send a notice to all 134 Teacher Education Institutions u/s 17 of NCTE Act, 1993 affiliated to Dr. Bhim Rao Ambedkar Vishwavidyalaya, Agra, Uttar Pradesh in order to seek their comments on the complaints raised by the affiliating university.

5. **AND, WHEREAS**, the institution has not submitted reply in NRC Office till date. The matter was considered by the NRC in its 315<sup>th</sup> (Virtual) Meeting held from 17<sup>th</sup> to 20<sup>th</sup> August, 2020 and the Committee decided as under:-

**"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the Committee made following observations:-**

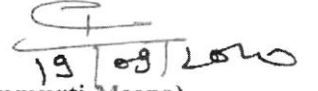
The second show cause notice issued to the institution on 10.02.2020 on following grounds:-

1. As per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition of the institution may be withdrawn as enough opportunities have been given to the institution.

Hence, NRC decided to withdraw the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. A detailed withdrawal order be issued to the college."

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of **Krishna Girls Academy, Plot No. – 313, Village – Laramda, Post Office – Bichpuri, Tehsil - Sadar, District – Agra, State – Uttar Pradesh** granted for **B.Ed.** course for an intake of 100 Seats (two units of 50 student each) vide order dated 23.09.2010 & Revised Recognition order dated 09.06.2015 on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.
