WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely Shri Pramhans Girls Degree College, Plot Number-72, 73, Street Number-Vidyakund, Village-Kajipur Vidyakund, Post Office-Ayodhya, Tehsil/Taluka-Faizabad, Town/City-Faizabad, District- Faizabad-224123, Uttar Pradesh run by Seva Sansthanam, Plot Number-811, Street/Road- Vidyakund, Village/Town/City-Kajipur Vidyakund, Post Office- Ayodhya, Tehsil/Taluka-Faizabad, Town/City-Faizabad, District- Faizabad-224123, Uttar Pradesh vide Order No. F.NRC/NCTE/NRCAPP-7456/225th Meeting/72924-930 date 04.03.2014 for conducting (Secondary) B.Ed. Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 23.10.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 09.06.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 200 (two basic units) from the academic session 2015-16.
- **AND WHEREAS,** as per decisions taken by NRC in its 337<sup>th</sup> (Virtual) meeting, the recognition was withdrawn by NRC vide order no. NRC/NCTE/NRCAPP-7456/337<sup>th</sup> Meeting/2021/214646-51 dated 16.07.2021 from the end of the academic session rext academic session 2022-2023.
- **4. AND WHEREAS,** the institution filed an appeal in the NCTE Hqrs New Delhi against the NRC order dated 16.07.2021. The appeal committee remanded back the case vide order dated 22.10.2021 the matter was considered by the NRC in its 361<sup>th</sup> (Virtual) Meeting held on 13<sup>th</sup> to 14<sup>th</sup> January, 2022 and the Committee and decided to issue Show Cause Notice on the following grounds:-
  - 1. The NRC considered the Appeal order dated 22.10.2021 wherein the Appeal Committee directed to the institution to submit the required documents which are mentioned in the withdrawal order within 15 days.
  - 2. The institution has submitted its representation dated 16.11.2021 without any documentary evidence.

Accordingly, Show Cause Notice was issued to the institution on 25.01.2022

- 5. **AND WHEREAS**, the institution has submitted reply of Show Cause Notice received in NRC office on 26.02.2022 & 20.04.2022 the matter was considered by the NRC in its 380th Meeting (Blended mode) held on 08th October, 2022 and the Committee and decided as under: -
  - 1. Recognition of the institution for B.Ed. programme be continued with an intake of two units of 50 students each.
- 6. NOW THEREFORE, this order is issued permitting the institution i.e. Shri Plamhans Girls Degree College, Plot Number-72, 73, Street Number-Vidyakund, Village-Kajipur Vidyakund, Post Office-Ayodhya, Tehsil/Taluka-Faizabad, Town/City-Faizabad, District— Faizabad-224123, Uttar Pradesh run by Seva Sansthanam, Plot Number-811, Street/Road- Vidyakund, Village/Town/City-Kajipur Vidyakund, Post Office- Ayodhya, Tehsil/Taluka-Faizabad, Town/City-Faizabad, District— Faizabad-224123, Uttar Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **8.** The institution shall submit to the Regional Committee as Self Appraisal Report at the er.d of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- **9.** The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with

regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **9.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- 11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
