The recognition was granted by the Northern Regional Committee to Shri Vijay Swaroop Mahila College of Education, Plot/Khasra No.- PS-1, Pt. Deen Dayal Upadhyapuram, Sector-12, Sikandra, District- Agra, State- Uttar Pradesh, Pin Code- 282005 vide Order No., NRC/NCTE/F-3/UP-1247/2005/5222 dated 06.07.2005 for B.Ed. course of one year duration with an annual intake of 100 seats. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-1247/2015/100358-58 dated 18.05.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 students each was issued to the institution.

- The recognition was withdrawn to the institution for B.Ed. course for an intake of 100 seats from the end of the academic session next following the date of order of withdrawal vide Order No.- NRC/NCTE/UP-1247/311th Meeting/2019/208521-526 dated 09.07.2020.
- The Institution has filed W.P. (C) 12371/2022 in the High Court of Delhi. The Hon'ble High Court passed order dated 26/08/2022 with directions (1) withdrawal order dated 9/7/2020 shall remain stayed for the academic session 2022-2023; (2) NRC is directed to reflect the status of the petitioner College on its official website as a recognized institution for running B.Ed. course , and shall also communicate the same to petitioner college's affiliating university and the concerned State Govt. enabling them to participate in ongoing counselling process- so that it may admit students for the academic session 2022-2023 and (3) NCTE is directed to forthwith decide the pending statutory appeal of petitioner - College, in terms of the order dated 4/3/2021 in W.P. (C) 2900/2021".
- The matter was considered by NRC in its 379th Meeting (Virtual) held on 30th September, 2022 and the Committee decided to reflect the name of the institution on the official website as a recognized institution for running B.Ed. course for an intake of 100 students for the academic session 2022-2023. The affiliating University/ State Govt. may accordingly be intimated. And also decided to file LPA against the stay order dated 26/08/2022.
