Sub:- Compliance of decision of NRC in its 379th Meeting (Virtual) held on 30th September, 2022.

Sir/Madam,

The recognition was granted by the Northern Regional Committee to **Pt. Vashudev Tiwari College of Education, Plot/Khasra No.- 107, Purani Najhai Gulab Chand Seth Ki Haweli Ke Pass, Jhansi- 284004, Uttar Pradesh** vide Order No. NRC/NCTE/F-7/UP-2483/2008/40067-40073 dated 29.02.2008 for B.Ed. Course of one year duration with an annual intake of 100 seats.

2. The recognition was withdrawn to the institution for B.Ed. course for an intake of 100 seats from the end of the academic session next following the date of order of withdrawal vide order No.- NRC/NCTE/UP-2483/322nd (Virtual) Meeting/2020/213056-61 dated 08/02/2021.

3. The institution has filed W.P. (C) 12465/2022 & CM APPL 39224/2021. The Hon'ble High Court Passed Order dated 10/05/2022 with the following directions "*The writ petition is accordingly allowed by quashing the orders dated 8/2/2021 and 19/08/2021. It is however, made clear that this order will not come in the way of the respondent no. 2 initiating any fresh or further action against the petitioner in accordance with law.*

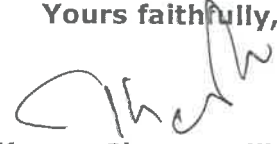
The respondent no. 2 is directed to take all consequential action including issuance of the notice on its web portal that the impugned withdrawal order against the petitioner has been quashed and the petitioner continues to be a recognized institution. This information will also be furnished to the affiliating university as well as all other relevant statutory authorities".

4. The matter was considered by NRC in its 379th Meeting (Virtual) held on 30th September, 2022 and the Committee decided to reflect the name of the institution on the official website as a recognized institution for the Academic Session 2022-2023 for B.Ed. course with an annual intake of 100 students.

The affiliating University/ State Govt. may accordingly be intimated.

5. In compliance of above Hon'ble High Court Order, it is clarified that the said institution is entitled to participate in counselling and admit students for the academic session 2022-2023.

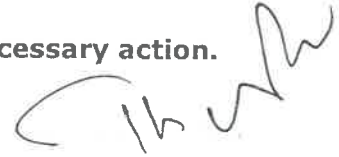
