Sub:- Compliance of decision of NRC in its 380th Meeting (Blended Mode) held on 08th October, 2022.

Sir/Madam,

The recognition was granted by the Northern Regional Committee to **Shri Kirori Lal Shastri Mahavidyalaya, Jagner, District- Agra, State- Uttar Pradesh** vide Order No. NRC/NCTE/F-7/UP-2024/148th Meeting/2009/9710-9716 dated 31.08.2009 with an annual intake of 100 seats from the academic session 2009-10 and in light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-2024/2015/145126-31 dated 08.04.2016 for B.Ed. course of two years duration with an annual intake of two units of 50 students each was issued to the institution with certain conditions.

2. The matter was considered by NRC in its 365th (Vol-II) (Blended Mode) Meeting held on 08th & 09th March, 2022 and the Committee decided that withdrawal order be issued to the institution from the session 2022-2023.

3. Accordingly, Withdrawal Order was issued to the institution vide Order No.- NRC/NCTE/UP-2024/365th Meeting/2022/218659-666 dated 19.07.2022.

4. The Institution has filed W.P.(C) 12339/2021 in the High Court of Delhi. The Hon'ble High Court passed an order dated 29.10.2021. The NRC in its 372nd Emergent Meeting (Blended Mode) Meeting held on 27th July 2022 considered the Court Order dated 29.10.2021 and the Committee decided as under:

"In compliance of the order dated 29/10/2021 of the Hon'ble High Court of Delhi in W.P. (C) No. 12339/2021, the matter was considered by NRC in its 353rd meeting and the institution was permitted to participate in Counselling for the session 2021-2022 with the direction to the institution to submit updated approved faculty list as per direction of appellate committee order dated 28.01.2021.

As the institution failed to submit the approval therefore NRC in its 365th Meeting held on 08th & 09th March, 2022 took the decision to withdraw the recognition and order dated 19.07.2022 was issued to the institution from the session 2022-23.

The matter was again considered by NRC in compliance of WP (c) No. 12339/21 and CC No. 748/2022 and decided that the withdrawal order 19.07.2022 be modified to the extent that the recognition of the institution

is withdrawn from the end of the academic session next following the date of communication of withdrawal order."

The institution is again directed to furnish the updated faculty list along with Bank statement of last 6 months confirming salary disbursement to the faculty".

5. Accordingly, letter was issued to the institution and concerned affiliating body and State Govt. vide Order No. NRC/NCTE/UP-2024-B.Ed./372nd Emergent Meeting (Blended Mode) Meeting/2022/218908-915 dated 18.08.2022.

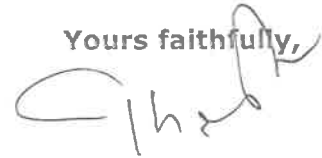
6. The institution has filed Cont. cas (C) 1037/2022 in the High Court of Delhi. The Hon'ble High Court passed order dated 28/09/2022 with the direction "It is submitted by Ms. Kaul, learned counsel for the respondents, that a clarifactory communication will be issued by the respondents clarifying that the withdrawal order dated 19/07/2022 would take effect from the end of the Academic Session 2023-2024 and that the petitioner would, therefore, be entitled to participate in counselling and admit students for the Academic Session 2022-23 and 2023-24. She further submits that the same will be issued as expeditiously as possible, and in any event, within one week from today. The said clarification/ communication be uploaded by the respondent on the website within a period of one week from today.

7. The matter was considered by NRC in its 380th Meeting (Blended Mode) held on 08th October, 2022 and the Committee decided that the status of the institution will remain as recognized institution up to the end of the Session 2023-2024. The petitioner institution would be allowed to participate in the counselling and admit students for the Academic Session 2022-2023.

The affiliating University/ State Govt. may accordingly be intimated.

8. In compliance of above Hon'ble High Court Order, it is clarified that status of the institution will remain as recognized institution up to the end of the Session 2023-2024 and the said institution is entitled to participate in counselling and admit students for the academic session 2022-2023.

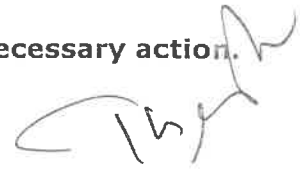
