# TO BE PUBLISHED IN GAZETTE ON INDIA PART III SECTION 4 ORDER

WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely Kripalu Mahila Mahavidyalaya, Kunda, Pratapgarh – 230204, Uttar Pradesh run by Kripalu Mahila Maha Vidyalaya Samiti, Kunda Pratapgarh, Uttar Pradesh vide Order No. F.NRC/NCTE/F-3/UP-1076/10120-10128 dated 09th November, 2004 for conducting (Secondary) B.Ed. Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit not submitted for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was not issued to the institution.
- 3. AND WHEREAS, the matter was considered by NRC in its 325<sup>th</sup> (Virtual) Meeting field on 08<sup>th</sup> to 09th January, 2021 the Committee decided to issue Show Cause Notice on the following grounds:-
  - 1. Whether the institution has submitted affidavit to NRC of NRC for issuance of Revised Recognition Order. If yes, please submit proof of the same and if not, then furnish reasons of non-submission of the affidavit to NRC.
  - 2. The institution has to submit whether they had submitted compliance with the conditions prescribed under Regulations, 2014 (Enhanced FDRs, Revised Staff Profile, Additional Built-up Area etc.) for consideration and decision of the Committee without issuance of Revised Recognition Order and after submission of affidavit from the list attached.
  - 3. If the institution does not fall in any of above two categories, then institution is required to inform NRC about their status in respect of Revised Recognition Order compliance matters.

Accordingly, Show Cause Notice U/S 17 issued to the institution on 19.01.2021.

- **AND WHEREAS,** the institution has submitted reply of Show Cause Notice U/S 17 regarding RPRO through mail dated 22.08.2022 alongwith affidavit dated 09<sup>th</sup> February, 2021 with a request to reduce the intake of 50 students (one unit) of two year duration for B.Ed. course. The matter was considered by the NRC in its 380<sup>th</sup> Meeting (Blended mode) held on 08<sup>th</sup> October, 2022 and the Committee and decided as under:
  - 1. The recognition to the institution was granted for B.Ed. course of one year duration for an annual intake of 100 seats vide order no. Fr NRC/NCTE/ F-3/JP-1076/2004/10120-10128 dated 9/11/2004.

2. The institution has submitted an affidavit to reduce the intake for 50 seats (One unit) of two year duration in line with post 2014 Regulations.

5. The institution has submitted PAR for the Academic Year 2020-2021.

In view of the above, the NRC has decided to allow Kripalu Mahila Mahavidyalaya, Kunda, Pratapgarh, Uttar Pradesh to continue the recognition for B.Ed. course for two-year duration with an intake of one unit (50 students.)

Mahila Mahavidyalaya, Kunda, Pratapgarh – 230204, Uttar Pradesh run by Kripalu Mahila Maha Vidyalaya Samiti, Kunda Pratapgarh, Uttar Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (one basic unit) of 50 students subject to fulfilment of the following conditions:-

The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

I.. The institution shall comply with the various other norms and standards prescribed

in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in

position.

- **6.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the erd of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with

regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, guarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **9.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- 11) The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
