CONTINUATION ORDER

(223780-223786) 12 OCT 2023

WHEREAS the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely **Bhagwant Singh Mahavidyalaya, Kaukhera Khalsa Post- Sharif Nagar, Distt. Moradabad-244602, Uttar Pradesh**. For conducting B.Ed. Course of one year duration with an annual intake of 100 (One hundred) vide order No. NRC/NCTE/F-3/UP-1155/5098-5106 dated 05.08.2004 and Additional Intake B.Ed. Course of one year duration with an annual intake 100 seats (Existing 100-additional 100 = 200) vide order No. NRC/NCTE/F-7/UP-2203/2007/46727-33 dated 26.04.2008 was also permitted.

2. **AND WHEREAS**, the revised recognition was granted to the institution for conducting B.Ed. programme of two years duration with an annual intake of 200 students for four basic units of 50 students each from the academic session 2015-2016 vide order No. NRC/NCTE/F-73/UP-2203/2007/46727-33 dated 26.04.2008.

After promulgation of NCTE Regulations, 2014, the institution has not consented to come under the Regulations 2014 and affidavit in this regard was also not submitted by the institution. Hence, revised recognition order for B.Ed. one year duration was not issued to the institution.

3. **AND WHEREAS**, as per decision of NRC in its 325th Meeting held on 08th & 09th January, 2021 and the committee decided issue show cause notice u/s 17 to the institution. Accordingly, Show Cause notice issued to the institution vide letter dated 19.01.2021. The institution has not submitted reply of Show Cause Notice.

4. **AND WHEREAS**, the institution has not submitted a reply of Show Cause Notice under section 17 of NCTE Act 1993 date 19.01.2021. The matter was placed before NRC in its 403rd (Online mode) Meeting held on 13th & 14th July, 2023 and the Committee decided that **final show cause** under section 17 of NCTE Act, 1993 be issued to institution. Reply of the First SCN has not been submitted by the institution. The institution has submitted reply on the basis of minutes uploaded on Website vide its letter dated 04.09.2023 attached at page no.648-872.

5. **AND WHEREAS**, the matter was consider by NRC in its 411th (blend Mode) Meeting held on 15 September 2023 and decide as under: -

The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The NRC in its 403rd meeting decided to issued Final SCN. The institution has submitted reply of Final SCN vide letter dated 04/09/2023. The matter was considered in NRC and the committee observed the following:

- The institution has submitted all required documents.

In view of the above, the NRC decided that Recognition continuation order for B.Ed. course & B.Ed. additional intake of two years duration with an annual intake of 200 students (four units) be issued to the institution.

NOW THEREFORE, this order is issued permitting the institution **Bhagwant Singh Mahavidyalaya, Kaukhera Khalsa Post- Sharif Nagar, Distt. Moradabad-244602, Uttar Pradesh** for continuation of recognition for B.Ed. and B.Ed. additional intake Programme for two-years duration with an annual intake of 200 (four basic units annual) subject to fulfilment of the following conditions:-

- (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- (v) Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- (vi) The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- (vii) The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
 - (a) Sanctioned programme(s) along with annual intake in the institution.
 - (b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left or joined during the last, quarter:
 - (d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - (e) Fee charged from students;
 - (f) Available infrastructural facilities;
 - (g) Facilities added during the last quarter;
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - (i) The affidavit with enclosure submitted along with application.
 - (j) The institution shall be free to post additional relevant information if it so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- (viii) The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.



(ix) The institution shall make available the list of students admitted on its official website.

(X). The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
