WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Shri Ram Janki Mahavidyalaya, Plot/Khasara No.- 1908, Street No.- 0, Village- Ram Nagar, Post Office- Amawasufi, Tehsil/Taluka- Milkipur, Town/City-Faizabad, District- Faizabad- 224121, Uttar Pradesh for conducting B.Ed. Course of one year duration with an annual intake of 100 (One hundred) vide order No. F.No. NRC/NCTE/NRCAPP-4440/225thMeeting/2014/73936-942 dated 04.03.2014.

2. AND WHEREAS, the revised recognition was granted to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-2016 vide order No. F.No. NRC/NCTE/NRCAPP-4440/2015/139179-84 dated 16.02.2016.

3. AND WHEREAS, the matter was placed in 281st Meeting held on 20th & 21st February, 2018 and the committee decided to issue Show Cause notice. Accordingly, Show Cause Notice issued to the institution vide letter dated 11.04.2018.

4. AND WHEREAS, the matter was placed in 337th meeting of NRC held on 8th & 09th July 2021 and the committee decided to issue Second Show Cause notice. Accordingly, Second Show Cause Notice issued to the institution vide letter dated 16.07.2021.

5. AND WHEREAS, the institution has submitted reply dated 16.07.2021 of Second Show Cause Notice Under Section 17 of NCTE Act, 1993. The matter was placed before NRC in its 406th meeting held on 01st to 03rd August 2023 and committee decided as under:

The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee made the following observation:

As per decision of NRC in its 337th meeting the Second SCN was issued to the institution on 16/07/2021.

The institution has submitted reply of Second SCN vide letter dated 23/07/2023.

The NRC considered the reply of the institution dated 23/07/2023 and decided that Recognition Continuation order for B.Ed. course of two years duration (two units of 50 students each) be issued to the institution.



6. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Shri Ram Janki Mahavidyalaya, Plot/Khasara No.- 1908, Street No.- 0, Village- Ram Nagar, Post Office- Amawasufi, Tehsil/Taluka- Milkipur, Town/City-Faizabad, District- Faizabad- 224121, Uttar Pradesh** for continuation of recognition for **B.Ed. Programme** for two-years duration with an annual intake of 100 (**two basic units annual**)) subject to fulfilment of the following conditions:-

- (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- (v) Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- (vi) The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- (vii) The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
 - (a) Sanctioned programme(s) along with annual intake in the institution.
 - (b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left of joined during the last, quarter;
 - (d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - (e) Fee charged from students;
 - (f) Available infrastructural facilities;
 - (g) Facilities added during the last quarter;
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - (i) The affidavit with enclosure submitted along with application.
 - (j) The institution shall be free to post additional relevant information if it so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- (viii) The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- (ix) The institution shall make available the list of students admitted on its official website.



(X). The institution shall fill the information on GIS Portal on the NCTE Website.

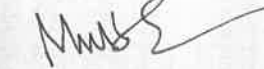
If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

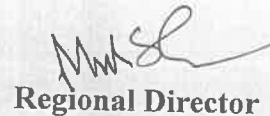
