WHEREAS, the recognition was granted to the institution viz. South Point College of Education, Purkhas Road, Near Sugar Mills Sonepat, Haryana by NRC vide Order No./ NRC/NCTE/F-7/HR-804/2007/29353-59 dt 29.09.2009 for conducting B.P.Ed. Course from the academic session 2007-2008 with an annual intake of 50 students.

WHEREAS, the matter was placed before NRC in its 281st Meeting held on 20th to 21st February, 2018 and the Committee decided that show-cause notice be issued to all such institution which did not submit compliance of the revised recognition orders.

WHEREAS, Show Cause Notice U/S 17 was issued to the institution vide letter No. F.No./NRC/NCTE/2018/193117-193222 dt.12.04.2018

WHEREAS, the institution has not submitted reply of Show Cause Notice dated 12.04.2018.

AND WHEREAS, the matter was placed before NRC in its 408th Meeting held on 16th & 17th August, 2023. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee decided that Final Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 7 days from the date of issue of Show Cause Notice. Accordingly, Final Show Cause Notice U/S 17 was No. F.No.NRC/NCTE/HRvide letter institution the 804/B.P.Ed/408th Meeting(SI.15)/2023/223248 dated 30.08.2023. The institution submitted its reply in response of Final Show Cause Notice on 11.09.2023.

WHEREAS, the matter was placed before NRC in its 412th Meeting held on 25th September, 2023. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The recognition was granted to the institution for B.P.Ed. course of one years with an annual intake of 50 students vide order dated 29/09/2007.

As per decision of NRC in its 408th meeting Final SCN was issued to the institution on 30/08/2023. The institution has submitted reply of final SCN vide letter dated 11/09/2023. The NRC considered the reply dated 11/09/2023 and observed the following:

The institution has submitted all required documents against the Final SCN.

In view of the above, the NRC decided that recognition continuation order for B.P.Ed. course of two years duration with an annual basic units of 100

(one hundred) students with two sections of 50 (fifty) each be issued to the institution.

NOW THEREFORE, in the light of above, the Northern Regional Committee, NCTE hereby allowed the institution viz South Point College of Education, Purkhas Road, Near Sugar Mills Sonepat, Haryana for continuing Recognition of B.P.Ed. course of two years duration with an annual basic unit of 100 (one hundred) students with two sections of 50(fifty) each.

- 5. Further the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, Affiliating University / Body, the State Government etc., as applicable.
- 6. The institution shall submit to the Regional Committee a Performance-Appraisal Report (PAR) at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 7. The institution shall maintain its own website with hyperlink to the NCTE website uploading the required information / documents as per clause 7(14) of the NCTE Regulations 2014 as amended time to time.
- 8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on tis official website.
- 9. If the Institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations, and orders made of issued there under, the action including withdrawal of recognition shall be taken by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
