WHEREAS, the recognition under section 14/(3)(a) of NCTE Act, 1993 was granted to the institution namely Raja Devi Degree College, Plot No. – 164,166, Village – Badokhar Khurd, Post office – Banda, Tehsil/Taluka – Banda, District – Banda, Uttar Pradesh for conducting B.Ed. Course of one year duration with an annual intake of 100 (One Hundred) vide order No. NRC/NCTE/F-7/UP-3156/150 meeting/2009/11754-11760 dated 29.10.2009.

- 2. **AND WHEREAS,** the revised recognition was issued to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-2016 vide order No. NRC/NCTE/UP-Common Orders/2015/114788-114811 dated 07.06.2015.
- 3. **AND WHEREAS,** as per decision of NRC in its 315^{th} (Virtual Mode) Meeting held on 17^{th} & 20^{th} August, 2020 the recognition was withdrawn to the institution for B.Ed. vide order No. NRC/NCTE/NRC/NCTE/UP-3156/315th Meeting/2020/209267-72 dated 09.09.2020.
- **AND WHEREAS,** the institution filed an appeal in the NCTE Hqrs New Delhi against withdrawal order dated 09.09.2020. The appeal committee passed an order dated 27.11.2020 and the Council hereby remands back the case of Raja Devi Degree College, Banda, Uttar Pradesh. The matter was considered by NRC in its 325th meeting (Virtual) held on 08th to 09th January, 2021 and committee decided to issue Show Cause Notice under section 17 of the NCTE Act, 1993 following grounds:-
 - The latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D.(NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma are required to be submitted.

2. Details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member has not been submitted.

3. Downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014 has not been submitted.

Accordingly, Show Cause Notice under section 17 of the NCTE Act, 1993 was issued to the institution on 24.03.2021.

वर्षेष कुनुम्कम् one earth • one family • one future 5. **AND WHEREAS,** the institution has submitted reply dated 08.08.2023 of the first show cause notice under section 17 of the NCTE Act, 1999 received in NRC office on 10.08.2023 The matter was considered by NRC in its 411th meeting (Blended Mode) held on 15th September, 2023 and the committee decided as under:

" The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

As per decision of NRC in its 325^{th} meeting SCN was issued to the institution on 24/03/2021. The institution has submitted reply of SCN vide letter dated 08/08/2023. The matter was considered in NRC and the committee observed the following:

The institution has submitted all required documents.

In view of the above, the NRC decided that Recognition continuation order for B.Ed. course of two years duration with an annual intake of 100 students (two units) be issued to the institution".

- 6. NOW THEREFORE, this order is issued permitting the institution i.e. Raja Devi Degree College, Plot No. 164,166, Village Badokhar Khurd, Post office Banda, Tehsil/Taluka Banda, District Banda, Uttar Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 100 (two basic units) of 50 students each subject to fulfilment of the following:-
 - (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

(ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

(iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

(iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position

- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional

facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

(a) Sanctioned programme(s) along with annual intake in the institution.

(b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

(c) Name of faculty members who left of joined during the last, quarter:

(d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

(e) Fee charged from students;

(f) Available infrastructural facilities;

(g) Facilities added during the last quarter;

(h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

(i) The affidavit with enclosure submitted along with application.

- (j) The institution shall be free to post additional relevant information if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
