#### **ORDER**

And Whereas, the institution has submitted application for shifting premises of the institution- Vikram Singh Kanya Mahavidyalaya, Mugalsarai, District Chandauli, State Uttar Pradesh to Vikram Singh Kanya Mahavidyalaya, Arazi No. 32, 33, 39Angh & 39Gha, Mauza- Chandhasi, Paragna-Ralhupur, Mughalsarai, District Chandauli, State Uttar Pradesh 232101 for B.Ed. course vide letter dated 18.03.2020 received in NRC office on 18.03.2020.
- **3.** And Whereas, the matter was consideration by NRC in its 335<sup>th</sup> (Virtual) Meeting held from 15<sup>th</sup> to 16<sup>th</sup> April, 2021 and the Committee decided to issue Show Cause Notice U/S 17 following grounds:-
  - 1. NOC from the affiliating body is not submitted.
  - 2. Certified copy of the proposed land not submitted.
  - 3. The institution has not submitted any proof/evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
  - 4. Resolution of Society stating reasons of shifting has not been submitted.

Accordingly, Show Cause Notice U/s 17 issued to the institution on 10.01.2021.

- **4. And Whereas**, the instituting has submitted reply of Show Cause Notice U/s 17 received in NRC office on 05.02.2022. The matter was placed before NRC in its 365<sup>th</sup> (Vol. 1) (Blended Mode) (Virtual) Meeting held from 08<sup>th</sup> & 09<sup>th</sup> March, 2022 and the Committee decided to issue Final Show Cause Notice U/S 17 following grounds:-
  - 1. Society Registration details needed with the details of each member.
  - 2. List of the society members to be submitted.
  - 3. Resolution of the society is needed on the society letter head.

Accordingly, Show Cause Notice U/s 17 issued to the institution on 23.03.2022.

- **5. And Whereas**, the instituting has submitted reply of Show Cause Notice received in NRC office on 15.03.2022. The matter was consideration by NRC in its 380<sup>th</sup> Meeting (Blended Mode) Meeting held from 08<sup>th</sup> October, 2022 and the Committee decided to issue Show Cause Notice following grounds: -
  - 1. The institution is required to submitted certified copy of land documents.
  - 2. The institution is required to submit faculty list approved by the Affiliating body.
  - 3. The institution is required to submit Building Completion Certificate issued by the competent authority.
  - 4. The institution is required to submitted FDRs Rs. 5 lakhs and Rs. 7 Lakhs towards endowment fund and Reserve Fund,
  - 5. The institution is required to submit building plan approved by the competent authority.
  - 6. The institution is required to submit proof of own website.
  - 7. The institution is required to submit an affidavit for the status of migration of the institution into multidisciplinary institution.

Accordingly, Show cause notice issued to the institution on 11.10.2022.

- **6. And Whereas**, the instituting has submitted reply of Show Cause Notice received in NRC office on 11.10.2022 The matter was consideration by NRC in its 383<sup>th</sup> (Blended mode) Meeting held on 31<sup>th</sup> October, & 01<sup>st</sup> November, 2022 and the Committee decided to constitute VT. The online inspection was conducted an 22.12.2022 and the VTR was received in the office of NRC on 22.12.2022.
- **7. And Whereas**, the VTR was considered by NRC in its 390<sup>th</sup> Meeting (Blended mode) Meeting held on 20<sup>th</sup> and 23<sup>rd</sup> January, 2023 the Committee decided as under:-
  - The committee decided to permit the Shifting of institution from Araji No. 32,33,39 angh & 39 gha Mauza- Chandausi, Paragna- Ralhupur, Post Office - Mugalsarai, District- Chandauli, Pin-232101, Uttar Pradesh.
