Sub: Compliance of decision of NRC in its 386th meeting (Virtual) held on 23rd November 2022.

Sir,

The recognition was granted by the Northern Regional Committee to Smt. Prem Lata Maya Devi Agrawal Girls Degree College, District- Mathura-281204, Uttar Pradesh for B.Ed. course with an annual intake of 100 seats, w.e.f. 11/08/2005 vide order No. F. NRC/NCTE/F-3/UP-1253/8928-8937 dated 16/08/2005 and revised recognition order was issued to the institution for B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 vide order No. F. No./NRC/NCTE/UP-1253/2005/112348-51 dated 06/06/2015.

- 2. The recognition for B.Ed. course was withdrawn to the institution vide order No. File. No. /NRC/NCTE/UP-1253/311th Meeting/2019/208561-66 dated 10/07/2020.
- 3. The institution filed W.P. (C) 8188/2020 in the High Court of Delhi. The Hon'ble High Court passed order dated 7/10/2020. The matter was considered in NRC in its 383^{rd} meeting held on 31^{st} & 1^{st} November 2022 and the committee decided to file an LPA along with a stay application against the order dated 7/10/2022 passed by the Hon'ble High Court of Delhi in the W.P. (C) No. 8188/2020.
- 4. In the meanwhile the institution filed a contempt Petition No. 1237/2022 in the High Court of Delhi. The matter was again considered by the NRC in its 386th meeting held on 23rd November 2022 and the committee observed that the LPA filed by the NRC was listed for hearing before the bench led by the Hon'ble Chief Justice of Delhi High Court. The learned Counsel appearing for NRC, NCTE has informed about the proceedings of the Hon'ble Court through E-mail on the official mail of legal NRC. Accordingly, the learned Court was pleased to issue notice in this matter. However, no stay on the impugned order dated 7/10/2022 was granted.

Hence, in view of the above, the NRC decided to allow the institution to participate in the counselling to admit students for the Academic Session 2022-2023. Further, it is also decided to send an intimation to the Affiliating University and the Department of Education accordingly.

5. In compliance of the above decision of NRC, Smt. Prem Lata Maya Devi Agarawal Balika Shiksha Samiti, Raya, Mathura, Uttar Pradesh is permitted to participate in the counselling for B.Ed course to admit students for the academic session 2022-2023.
