WHEREAS in terms of section 14(1) of the NCTE Act, 1993 Jagadguru Ranbhadracharya Handicapped University, Karwi, Chitrakoot-210204, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting M.Ed Course of one year duration with an annual intake of 25 (Twenty Five Only) students on 24.01.2007.

AND WHEREAS, as per decision taken by NRC in its 113th Meeting, the conditional recognition was

granted to Institution vide order dated 24.01.2007.

AND WHEREAS, the matter was placed before the NRC in its 160th Meeting held from May 18th -20th, 2010 and as per decision, the recognition was refused vide NRC's order dated 03.06.2010.

AND WHEREAS, the Institution had preferred an appeal before the Council (NCTE, New Delhi) against the aforesaid order. The Council vide order dated 22.09.2010 issued direction to the NRC to issue modified order withdrawing the recognition of the Institution.

- AND WHEREAS, in compliance or the appeal order, the case was considered by NRC in its 168th Meeting held from October 5th-8th, 2010 and it was observed that the refusal order of NRC dated 03.06.2010 be modified as order of withdrawal of recognition from the next academic session. Accordingly, the recognition of the Institution was withdrawn vide NRC's order dated 19.11.2010.
- AND WHEREAS, the Institution had filed a Writ Petition No. 26420/2011 in the Hon'ble High Court of Allahabad. The Court had passed order dated 06.05.2011 which is reproduced below:

"However, considering the aforesaid fact, including that now it is claimed that the faculty has been appointed, the respondent No. 1 may consider the prayer of the petitioner for grant of recognition in accordance to law, if possible, within a period of eight weeks from the dated of submission of a certified copy of the order."

- AND WHEREAS, in compliance of the Court Order, the case was considered by NRC in its 186th Meeting held from August 8th -10th, 2011 and it was observed that the representation of the Institution alongwith orders of the Hon'ble Court has been considered. The University be asked to submit experience certificate in respect of Dr. Shyam Dhar Tiwari and Dr. Shiya Ram Yadav appointed Professor and Associate Professor, so as to indicate their experience of teaching at M.Ed. Level for a period of 5 years and 3 years respectively which is essential as per NCTE Norms. Accordingly, letter was issued to the University on 10.11.2011.
- AND WHEREAS, the reply submitted by the Institution was considered by NRC in its 190th Meeting and it was decided that the recognition for M.Ed. Course with an annual intake of 35 seats from the academic session 2012-2013 be granted under clause 7(11) of NCTE Regulation 2009.
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the NRC hereby grants the recognition to the Jagadguru Ranbhadracharya Handicapped University, Karwi, Chitrakoot-210204, Uttar Pradesh for conducting M.Ed. Course of two years duration with an annual intake of 35(Thirty Five only) students under clause 7(11) of NCTE Regulations, 2009 from the academic session 2012-2013 subject to the following conditions:

The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

- 10. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- 11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff.
- 12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.
- 13. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
 - 14. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
