 - f. Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), us per the norms of the NCTE / UGC / Affiliating University CIONA
