CONTINUATION ORDER

WHEREAS the recognition was granted to the institution namely Jawaharlal Nehru Smark Post Graduate College, District – Maharajganj – 273303, Uttar Pradesh for B.Ed. course of one year duration with annual intake of 90 (Ninety) students vide order No. F.NRC/NCTE/F-3/UP-63/B.Ed./2000/4254-69 dated. 24.07.2000 followed by revised recognition order for B.Ed. course of two year duration with an annual intake of 100 students i.e. two basic units of 50 students each vide order No. F. No./NRC/NCTE/UP-243(UP-63)2015/114880-85 dated 08.06.2015.

- **2. AND WHEREAS,** as per the decision of NRC in its 281st Meeting held on 20th to 21st February 2018, show cause notice u/17 was issued to the institution vide letter No. F.NRC/NCTE/NRCAPP/UP-243/2018/191326 dated 23.03.2018. The institution had not submitted any reply to show cause notice dated 23.03.2018.
- **3. AND WHEREAS,** as per the decision of NRC in its 406th (Part-1) Meeting held on 01st to 03rd August, 2023, final show cause notice under Section 17 of the NCTE Act, 1993 was issued to the institution to submit reply within 7 days from the date of issue of show cause notice on 14.08.2023. The institution had submitted reply dated 01.09.2023.
- AND WHEREAS, the matter was considered in 412thMeeting of NRC held on 25th
 September 2023 and the Committee decided as under: -

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

As per decision of NRC in its 406th meeting (Part-1) held on 01st August to 3rd August 2023 Final SCN was issued to the institution on 14/08/2023.

The institution has submitted reply of Final SCN vide letter dated 01/09/2023 received in NRC office on 12/09/2023. The matter considered in NRC and the committee observed the following:

- The institution has not submitted certified land documents issued by Govt. Competent Authority.
- The institution has submitted building plan but not approved by the Govt. Competent Authority and not mentioned earmarked area for each course being run in the same premises.

- The institution has not submitted land use certificate issued by the Govt. Competent Authority.
- The institution has not submitted latest Non Encumbrance Certificate issued by Govt. Competent Authority.
- The institution has submitted Building Completion Certificate but not issued by the Govt. Competent Authority.
- The institution has not submitted details of salary disbursed to the faculty along with six months Bank statement and Account number of each faculty members.
- The institution has not submitted faculty list approved by the affiliating body.
- The institution has submitted consolidated list for 08 faculty signed by Manager of the college.
- As per consolidated list the institution has not appointed Music, Fine Art and Physical Education Faculty.
- The institution has not appointed 16 faculties as per NCTE Regulations 2014 for B.Ed. Two basic units.
- The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.

Hence, the committee decided to withdraw the recognition of B.Ed course under section 17 of NCTE Act, 1993 from the academic session 2024-2025."

Accordingly, withdrawal Order was issued to the institution on 29.03.2025.

5. AND WHEREAS, the institution preferred an appeal and the Appellate Authority passed an Order No. File No. 89-213/E-322071/2023 Appeal/15th Meeting, 2023 APPLNRC202314634/123198 dated 19/12/2023 as under: -

"After perusal of the Appeal Report documents on record and oral arguments advanced during the online hearing Appeal Committee of the Council concluded to remand back the case to NRC with a direction to verify the submitted documents filed by the appellant institution with the appeal from the records available with NRC and if it feel necessary and appropriate then documents may also be verified from the concerned competent authority. The appellant institution is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of the appeal and after receipt of the same the NRC to take further necessary action as per the NCTE Regulation 2014, guidelines and amendments issued from time to time in terms of direction given herein above"

6. AND WHEREAS, the representation of the institution received in NRC office on 28.12.2023 was considered by the NRC in its 418th meeting held on 23rd and 24th January 2024 and the Committee decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the NRC after careful consideration made the following observations: -

The institution is running the course under a self-financing scheme and is a grant in aid college and is running B.Ed., B.P.Ed. and M.Ed. Courses. The reply/documents submitted by the institution as directed by the Appeal Committee of NCTE suffers from the following discrepancies.

- (i) The Appeal Committee remanded back the case to NRC for consideration of the matter for one basic unit. In this regard, the institution is required to submit its request for a reduction of 1 unit of B.Ed. Course which has not been submitted.
- (ii) The institution submitted the proforma of faculty signed by the Registrar, Siddharth University, Kapilvastu, Siddharth Nagar, U.P. vide, which only 11 faculty members have been approved which are not sufficient to run B.Ed. course with 2 units. Further, 3 faculty appointed for Physical Education, Music, and Arts (Lalit kala) have been appointed on part-time basis which is not permissible under the provisions stipulated in Appendix 4 of NCTE Regulations, 2014.
- (iii) The institution is required to submit a copy of the affiliation orders of the last three years with intake capacity issued by the concerned affiliating body for each course being run by the institution/society."

Therefore, the committee decided to issue First Show Cause Notice u/s 17 of NCTE Act, 1993, before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 30 days from the date of issue of Show Cause Notice."

7. **AND WHEREAS**, reply of show cause notice submitted to the institution 19.02.2024 received in NRC on 27.02.2024 was considered by the NRC in its 422th meeting held on 06th and 07th June 2024 and the Committee decided as under: -

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

• The reply submitted by the institution has been considered by the NRC and the same was found satisfactory, Hence, the Committee decided that the status quo of the institution be maintained, and recognition granted is hereby continued.

Letter/Order be issued accordingly to all concerned.

8. AND WHEREAS, during the action taken of the above minutes, it was observed that the institution has itself requested for one unit of B.Ed. course, however, the decision of NRC to maintain the *status quo* to continue recognition may lead continuation of recognition of 2 units of B.Ed. course.

9. AND WHEREAS, the matter was reconsidered by the NRC in its 442nd NRC meeting held on 11th & 12th June 2025 and Committee decided as under:-

"The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee noted the following: -

- The recognition was granted to the institution namely Jawaharlal Nehru Smarak Post Graduate College, District Maharajganj 273303, Uttar Pradesh for B.Ed. course of one year duration with annual intake of 90 (Ninety) students vide order No. F.NRC/NCTE/F-3/UP-63/B.Ed./2000/4254-69 dated. 24.07.2000.
 - The Committee considered the matter of the institution and rectified the decision taken by NRC in its 422th meeting held on 06th and 07th June 2024 as under: -
 - The reply submitted by the institution has been considered by the NRC and the same was found satisfactory, Hence, the Committee decided to restore the recognition for conducting the B.Ed. course by the institution with an annual intake of 50 students i.e. one basic unit of 50 students.

Continuation Order be issued accordingly to all concerned".

10. NOW THEREFORE, in terms of the decision of NRC, the recognition granted to the institution namely Jawaharlal Nehru Smarak Post Graduate College, District – Maharajganj – 273303, Uttar Pradesh for conducting B.Ed. course with an annual intake of 50 students i.e. one basic unit of 50 students is hereby continued.
