- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to BABA JAI RAM DASS COLLEGE OF EDUCATION VILL & POST PALI MOHENDER GARH-123029, HARYANA for an additional intake of 100 students in B.ED course of 1 year duration and thereby making the annual intake of 200 students under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following:
 - (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.
