ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Sri Vidya Sagar Academy Shikshan Sansthan, Plot No. – 498, Street/Road-Sagar Road National Highway, Village/Town/City-Lalitpur, Post Office-Lalitpur, Tehsil-Lalitpur, District – Lalitpur-284403, State-Uttar Pradesh for B.Ed. course vide Order No. NRC/NCTE/NRCAPP-4903/233rd Meeting/Common Order/90563-591 dated 15.03.2015 with an annual intake of 100 seats from the academic session 2015-2016.

AND. WHEREAS, the institution submitted a representation, received in the NRC office on 14.02.2014 requesting for change of name of the institution from Sri Vidya Sagar Academy Shikshan Sansthan, Plot No. – 498. Stret/Road-Sagar Road National Highway, Village/Town/City-Lalitpur, Post Office-Lalitpur, Tehsil-Lalitpur, District – Lalitpur-284403, State—Uttar Pradesh to Shri Deep Chandra Choudhary Mahavidyalaya, Plot No. – 6582/2M & 6583/1, Street No.-Sagar Road, Village-Hadh Bahar, Nagar Palika, Post Office-Lalitpur, Tehsil-Lalitpur, District – Lalitpur-284403, State—Uttar Pradesh.

AND. WHEREAS, the matter was placed before the NRC in its 327th (Virtual) Meeting held on 08^{th} to 10^{st} February, 2021 and the Committee decided as under:

"The original file of the Institution—alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the Committee made following observations:

In compliance with the Hon'ble High Court of Delhi at New Delhi Order dated 10.12.2020 in W.P. (C) 9993/2020 and 29.01.2021 in CONT.CAS(C) 891/2020, the Committee made following observations:

- 1. The case was put up in 323rd Meeting in Compliance of Court Order dated 10th December, 2020.
- 2. It is mentioned in NRC Minutes dated 17th December, 2020 (323rd Meeting Item No. 17) "In compliance with the Hon'ble High Court of Delhi at New Delhi Order dated 10.12.2020 passed in W.P.(C) No. 9993/2020.
- 3 The Committee has considered the matter and observed that:
 - i. As per records of NRC, NCTE, No application has been submitted in NCTE by the institution i.e. Shree Deep Chand Chaudhary Mahavidyalaya, Uttar Pradesh to grant recognition for any teacher education course.
- ii. As per NRC's records, NRC has not granted any recognition to the institution i.e. Shri Deep Chandra Chaudhary Mahavidyalaya, Uttar Pradesh for any teacher education course so far. Hence, the Committee decided:
 - i. Not to intimate the University about participation in the counselling. Accordingly, the decision of the Committee may apprise to the Hon'ble High Court of Delhi
 - ii. To write a letter to the affiliating university to apprise the NRC, NCTE about the basis of affiliation granted to the said institution and allowing to participate in counselling since 2015 as mentioned in court order."

The matter of institution again put up before committee for the compliance of court order (contempt) dated 29th January, 2021.

The committee observed that

4. The institution made an application dated 28.12.2012 in the name of Kamlesh Jain run by Shri Vidya Sagar

- 5. Letter on vide an Affidavit dated 28.06.2013 the society Shri Vidya Sagar Academy Shikshan Sansthan
- 6. passed the resolution on 06.12.2012 for submitting application recognition B.Ed. course in the name of Shri Deep Chand Choudhary Mahavidyalaya.
- 7. VT constituted on 24.10.2013 in the name Kamlesh Jain run by Shri Vidya Sagar Academy Shikshan Sansthun.
- 8. Visiting team for physical verification of the institution was conducted in the name of Kamlesh Jain and the VT submitted its report in the name of Shri Deep Chandra Choudhary Mahavidyalaya.
- 9. NRC decided to issue SCN on "Name of the institution on online application is Kamlesh Jain whereas the name of the institution in the affidavit & banner of the institution is Deep Chand Chaudhary Mahavidyalaya" (224th Meeting held on 28th January to 02nd February, 2014.)
- 10. The institution in its reply dated 14.02.2014 requested that name of the institution a may kindly be correct as Shri Deep Chand Choudhary Mahavidyalaya instead of Kamlesh Jain).
- 11. NRC Minutes dated 25th February to 01st March 2014 (225th Meeting-LOI Item No. 728) in the name of Kamlesh Jain (Shri Deep Chandra Choudhary Mahavidyalaya).
- 12. LOI issued dated 22.01.2015 in the name of "Shri Vidva Sagar Academy Shikshan Sansthan"
- 13. The Recognition Order was issued on 03.03.2015 in the name of "Shri Vidya Sagar Academy Shikshan Sansthan".
- 14. Institution obtained affiliation from the University on 08.05.2015 with the name of Deep Chand Choudhary Mahardvalaya.
- 15. Institution with the name of Deep Chand Choudhary has been participating in the counselling since 2015.
- 16. The students informed to the institution that his/her verification of OTPRMS is not verified by NRC, NCTE because name of the institution in degree does not match with recognition order of NCTE.
- 17. Therefore the institution applied for change in name viz Shri Deep Chandra Choudhary Mahavidyalaya, instead of
- 18. "Shri Vidya Sagar Academy Shikshan Sansthun".
- 19. Land documents dated 29.06.2010 are in favour of Shri Deep Chandra Choudhary Mahavidyaloya.
- 20. Minority status Certificate dated 20.03.2014 in favour of Shri Deep Chandra Chondhary Mahavidyalaya.
- 2? Committee also took cognigence of letter from Bundel khand univ. no.1754 dated 01.11 2020 regarding affiliation of institution.

Although No specific direction has been passed by the Hon'ble Court for rectifying the institution's name but the Committee considered the matter in detail and decided

To rectify the name of the institution as Shri Deep Chandra Choudhary Mahavidyalaya in place of Shri Vidya Sagar Academy Shikshan Sansthan in the interest of the students.

The Affiliating University and state govt, should also be informed accordingly.

NOW. THEREFORE, the Northern Regional Committee hereby grants permission to the institution for change of its name from Sri Vidya Sagar Academy Shikshan Sansthan, Plot No. – 498, Stret/Road-Sagar Road National Highway, Village/Town/City-Lalitpur, Post Office-Lalitpur, Tehsil-Lalitpur, District - Lalitpur-284403, State-Uttar Pradesh to Shri Deep Chandra Choudhary Mahavidyalaya, Plot No. – 6582/2M & 6583/1, Street No.-Sagar Road, Village-Hadh Bahar, Nagar Palika, Post Office-Lalitpur, Tehsil-Lalitpur, District - Lalitpur-284403, State-Uttar Pradesh for conducting B.Ed. programme of two years duration with annual intake 100 for two basis units of 50 students each.
