WHEREAS, in terms of Section 15 of the NCTE Act, 1993, the S.P. College, Khasra No.-214, 217, 207, Khata No.187, Village - Tigri, Post-Ronia, Tehsil-Chandpur, Distt.-Bijnor-246725, Uttar Pradesh had applied in the office of NRC for permission for B.P.ED course under section 15 of NCTE Act, 1993 on 27.10.2008.

AND WHEREAS, the inspection of the institution was conducted under section 15 on 29.08.2009. The original file of the institution. VTR along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 150th meeting held from October 09-11, 2009 and the committee decided to issue show cause notice to the institution. Accordingly, Show-cause notice was issued to the institution on 30.10.2009.

AND WHEREAS, the reply received in response to the Show-cause notice was considered by NRC in its 154th Meeting held from January 09-11, 2010 and it was decided that VT may be sent against.

AND WHEREAS, the re-inspection of the institution was conducted on 23.02.2010. The original file of the institution, VTR of the Institution along with all other related documents, Act of NCTE. 1993. Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 158th Meeting held from April 19-22, 2010 and the committee decided to close the file. Accordingly, file of the institution was closed vide order dated 11.05.2010.

AND WHEREAS, the above said institution, thereafter preferred an appeal to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 24.09.2010 accepted the appeal and reverse the order of the NRC dt. 12-05-10 with the direction to NRC to issue a fresh show cause notice to the institution on the grounds mentioned in the order dated 11.05.2010 of NRC and take further action thereafter.

AND WHEREAS, the appeal order dated 24.09.2010 was placed in the 168th Meeting held from October 5-8, 2010 and it was decided to issue fresh show cause notice on the grounds mentioned in the order of NRC dated 11.05.2010. Accordingly. show-cause notice was issued on 15.11.2010 to the institution.

AND WHEREAS, the reply of the institution dated 30.11.2010 w.r.t. points of show cause notice dated 15.11.2010 has been carefully considered by NRC in its 175th Meeting held on December 30-31, 2010 in the light of photographs, affidavit and other documents submitted for its physiology lab, Psychology lab, Gymnasiums. Library etc. and it has been decided that the Institution be issued Letter of Intent Prior to grant of Recognition under clause 7(9) of the NCTE Regulation, 2009. Accordingly, letter was issued on 02.02.2011.

AND WHEREAS, the reply of the institution dated 21.01.2011 & 07.03.2011 and the original file was considered by NRC in its 180th Meeting held from March 23-26, 2011, March 31-April 1, 2010, and April 9-11, 2011 and NRC decided that Formal Recognition order under Clause 7(11) of the NCTE Regulation, 2007 be issued for B.P.Ed. Course with intake of 50 seats.

NOW, THEREFORE, in exercise of the powers vested under section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to S.P. College, Khasra No.-214, 217, 207, Khata No.187, Vill. Tigri, Post-Ronia, Tehsil-Chandpur, Distt.-Bijnor-246725, Uttar Pradesh for conducting B.P.Ed One year Course with an annual intake of 50 (Fifty Only) students from the academic session 2011-2012 under clause 7(11) of NCTE Regulations subject to the following conditions:

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as ii) amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause iii) 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc. wherever applicable.
