ORDER

In terms of Section 14(1) of the NCTE Act, 1993 **Smt. Rama Devi Mahila Mahavidyalaya, Jhinhak, Distt. Kanpur Dehat, Uttar Pradesh - 209302** had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for starting **B.Ed.** Course of One year duration from the academic session **2002-2003** with an annual intake of **120 (One Hundred Twenty)** students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-

- (a) The institution has acquired the land for setting up the teacher education institution.
- (b) The institution has constructed the building for conducting the course on the above mentioned land.
- (c) The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only) and a Reserve Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only).
- (d) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Smt. Rama Devi Mahila Mahavidyalaya, Jhinhak, Distt. Kanpur Dehat, Uttar Pradesh - 209302** for **B.Ed. course of One year duration** from the academic session **2003-2004** with an annual intake of **100 (One Hundred)** students **Subject to fulfillment of the following :-**

- (a) The institution shall function with at least 07 (Seven) teachers and 01 (One) Principal qualified as per norms of NCTE and that of the affiliating authority :-
- (i) The faculty members are to be appointed following the selection procedures as per the rules of the affiliating University and that of the State Government.
- (b) The institution shall follow the curriculum transaction as per NCTE norms.
- (c) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR only for a period of not less than SIXTY MONTHS (Five Years) in a Nationalized Bank (and not any other certificate) to be operated along with an official of the Regional Committee.
- (d) That the **Reserve Fund** for an amount equal to three months salary be maintained, in the form of FDR in favour of the management / institution, for a period of not less than SIXTY MONTHS in a Nationalised Bank.
- (e) The institution shall maintain fully equipped Laboratories and Library as per NCTE norms.
- (f) The institution shall produce *within one month from the date of issue of this order, a statement of staff with break-up of qualifications and experience* and also the documents related to formation of Selection Committee, Advertisement and minutes of the Selection Committee duly countersigned by the nominee of the concerned University.
- (g) The institution shall submit the *Performance Appraisal Report* of each academic year within four weeks' from the date of final examination conducted by the affiliating / examining authority.

(h) The institution shall follow such other rules and regulations as may have been prescribed by NCTE from time to time.

4. Recognition is subject to the condition that the affiliating university shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating University.

5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

6. The institution shall submit to the Regional Committee a **Self-Appraisal Report** at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
