WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely Maa Sharda Vidhyapeeth, Plot/Khasra Number- 115, 130, Street Number-NA, Village-Sehra, Post office-Sehra, Tehsil/Taluka-Siyana, Town/City-Siyana, District- Bulandshahr (UP)-245411, Uttar Pradesh for B.Ed. course of two-year duration with annual intake of 50 (Fifty) students from the academic session 2017-2018 vide order No. F.NRC/NCTE/Recognition/B.Ed./2016/150079-88 dated 08.06.2016.

- 2. AND WHEREAS, the institution filed writ petition No. 52006 of 2017 before the Hon'ble High Court of Judicature at Allahabad. The Hon'ble Court passed an Order dated 06.11.2017. The matter was placed before NRC in its 279th Meeting held on 16th & 17th January 2018, and the Committee noted that the Hon'ble High Court has not given any direction w.r.t. increase in the number of seats in B.Ed. Course. Accordingly, letter was issued to the institution on 29.01.2018.
- AND WHEREAS, a complaint letter dated 15/10/2024 & 24/10/2024 was received from 3. NCTE (HQ) for necessary action.
- **AND WHEREAS**, the matter was placed before NRC in its 430th meeting held (Volume-1) on 28th & 29th November, 2024 and the NRC decided that first Show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 21 days from the date of issue of Show Cause Notice on the following grounds:
 - Copies of affiliation orders (session-wise) for B.Ed. course issued by the affiliating body since grant of recognition by NRC-NCTE.
 - Copy of Recognition order/Revised Recognition order/ Continuation order/order of additional intake issued by NRC-NCTE, if any.
 - Year wise number of students admitted in the institution since grant of recognition by NRC-NCTE.

Further, the NRC also decided that the affiliating body of the institution i.e. CCS University, Meerut be requested to inform the intake of the institution for which the affiliation was granted by the University to the institution from time to time.

AND WHEREAS, first show cause notice was issued to the institution on 10.01.2025 and a letter was issued to the CCS University, Meerut on 10.01.2025. The institution had submitted reply of first show cause notice received in NRC office vide E-receipt no. 356431 dated 14.02.2025 and no reply was received from the University.

- **6. AND WHEREAS**, the matter was considered NRC in its 442nd Meeting held on 11th & 12th June, 2025 and the Committee considered the reply dated 14.02.2025 and observed the following.
 - 1. The institution has submitted affiliation letter dated 08.08.2019 issued by C.C.S. University, Meerut for B.Ed. 100 students but recognition for B.Ed. course was granted to the institution only 50 students (one unit).
 - 2. As per the decision of NRC in its 253rd Meeting Part-1, the recognition for B.Ed. Course 50 students (one unit) was granted to the institution vide order no. NRC/NCTE/ Recognition/B.Ed./2016150079-88 dated 08.06.2016.
 - 3. The institution made a fake Corrigendum Order No. F. No. NRC/NCTE/NRCAPP-7142/2016/150390-95 and increased its intake from 50 to 100 students for B.Ed. Course and also made a fake recognition order for two-units bearing order number F. No. NRC/NCTE/Recognition/B.Ed./2016/150079-88 dated 08.06.2016.

Hence, the Committee decided that that recognition granted to the institution for offering B.Ed. course be withdrawn under section 17(1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order and the institution shall not be entitled to admit the students from the academic session 2025-2026 onwards.

- 7. NOW THEREFORE, in exercise of the powers vested under Section 17(1) of the NCTE Act, 1993, the Northern Regional Committee decided to withdraw the recognition of the institution namely Maa Sharda Vidhyapeeth, Plot/Khasra Number- 115, 130, Street Number-NA, Village-Sehra, Post office-Sehra, Tehsil/Taluka-Siyana, Town/City-Siyana, District- Bulandshahr (UP)-245411, Uttar Pradesh for B.Ed. course with effect from the end of academic session next following the date of communication of withdrawal order and the institution shall not be entitled to admit the students from the academic session 2025-2026 onwards.
- 8. Further, if the institution is not satisfied with the order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
