"The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution namely Anjali Institute of Management, Etemadpur, Agra, Uttar Pradesh for B.P.Ed. course of one year duration with an annual intake of 100 students vide Order No. F. No. NRC/NCTE/F-3/UP-550/2002/10801 dated 18.02.2003.
