## ORDER- CUM-CORRIGENDUM

- 4. AND WHEREAS, the Committee considered the representation of the institution in its 447<sup>th</sup> meeting held on 03<sup>rd</sup> & 04<sup>th</sup> September, 2025, and decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, Rules. Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- The institution has submitted a representation dated NIL received in NRC office on 02/07/2025 requesting for correction the intake from 1 unit (50 seats) to 1 unit (100 seats) for B.P.Ed. Course as per NCTE Regulations 2014.

The Committee considered the request to the institution and decided to correct the intake for B.P.Ed. course from one unit 50 students to one unit 100 students in revised recognition order for B.P.Ed. course as per NCTE Regulations 2014.
