ORDER


WHEREAS, in terms of Section 14(1)/15(1) of the NCTE Act, 1993 the institution **M G Educational and Training College, Plot Number- Arazi No. 842, 843/1, 843/3, Street/Road-0, Village/Town/City- Sindhora, Post office-Sindhora, Tehsil/Taluka-Sadar, Town/City- Mirzapur, District- Mirzapur, (UP), State-Uttar Pradesh** had submitted an application online on 29.05.2015 to the Northern Regional Committee of NCTE for grant of permission for additional intake of D.El.Ed. Course.

2. AND WHEREAS, on scrutiny/perusal, veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution in compliance to the decision of clause 7(13) of the NCTE Regulations, 2014, as amended from time to time, the Northern Regional Committee having satisfied itself that the institution fulfills the requirements under the provisions of NCTE Act, Rules and the extant Regulations including the Norms and standards for proposed Teacher Education Course, such as instructional facilities, infrastructural facilities, library, recommendation, financial resources, laboratory, etc. for offering the course and had selected/appointed qualified teaching staff as per norms duly approved by the affiliating body, decided to grant recognition/permission to the institution in its 255th meeting held on 02nd to 06th August, 2016 for D.El.Ed. additional intake of 100 Students.

3. AND WHEREAS, as recorded in the 255th Meeting of the NRC, recognition for an additional intake of two units of D.El.Ed. course was granted to the institution with effect from the Academic Session 2017–2018. The institution has stated that it never received any formal recognition order in this regard. The non-receipt of the order remained unnoticed by the institution since it had been permitted to admit students continuously from the Academic Session 2017–2018 onwards without any objection or interruption from the authorities concerned. The records of NRC also reveal that the formal recognition order was never issued to the institution.

4. AND WHEREAS, the Committee was further informed that the petitioner institution has approached to the Hon'ble High Court of Delhi by filing W.P. (C) No. 16942/2025. The Hon'ble Court vide its Order dated 12.11.2025 disposed of the petition and directed the NRC–NCTE to issue a formal

order to the Petitioner Institution within a period of three weeks from the date of the order.

5. AND WHEREAS, the matter was placed before NRC in its 451st meeting (Volume-2) held on 19th, 20th & 21st November, 2025 the Committee took note of the directions issued by the Hon'ble High Court and decided for issuance of the formal order to the institution for offering D.El.Ed. (Addl.) intake **Order be issued accordingly.**

6. NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee, in compliance of order dated 12.11.2025 passed by the Hon'ble High Court of Delhi in W.P. (C) No. 16942/2025 hereby grants recognition/permission to the institution namely **M G Educational and Training College, Plot Number- Arazi No. 842, 843/1, 843/3, Street/Road-0, Village/Town/City- Sindhora, Post office-Sindhora, Tehsil/Taluka-Sadar, Town/City- Mirzapur, District- Mirzapur, (UP), State-Uttar Pradesh** for conducting D.El.Ed. (Additional) intake of two units of 100 students from the academic session 2017-2018 under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 as amended from time to time, subject to fulfilment of the conditions mentioned below:-

7. The institution shall adhere to fulfillment of the provisions of the NCTE Regulations, 2014 as amended from time to time.


8. The institution shall submit a Performance Appraisal Report online as and when required by NCTE.

9. The institution shall maintain & update its website as per provisions of the NCTE Regulations, 2014.

10. If the institution contravenes any of the provisions of the NCTE Act, Rules and Regulations made thereunder, the Regional Committee shall withdraw its recognition under provisions of section 17(1) of the NCTE Act, 1993.

11. Further, if the institution is not satisfied with this order, it may prefer an appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
