CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Jawahar Lal Nehru Smarak Post Graduate College, Maharajganj, Janpad, Maharajganj - 273303, Uttar Pradesh for M.Ed. Course of one year duration with an annual intake of 25 students from the academic session 2006-2007 vide NRC order No. NRC/NCTE/F-7/9971-78 dated 29.12.2006.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had not consented to come under the Regulations 2014 and affidavit in this regard was not submitted by the institution. Hence, revised recognition order for M.Ed. two years duration was not issued to the institution.
- 3. AND WHEREAS, the matter was placed before NRC in its 325th Meeting held on 08th to 09th January, 2021 and the Committee decided that Show Cause Notice under Section 17 issued to the institution.

Accordingly, Show Cause Notice under section 17 was issued to the institution on 19.01.2021.

- AND WHEREAS, the institution had not submitted a reply of Show Cause Notice under section 17 dated 19.01.2021. The matter was placed before NRC in its 406th Meeting (Part-1) held on 01st to 03rd August 2023 and Committee decided that final Show Cause Notice under section 17 of the NCTE Act, 1993 was issued to the institution on 14.08.2023.
- AND WHEREAS, the institution had submitted a reply of Final Show Cause Notice under section 17 vide letter dated 01/09/2023 received in NRC on 12.09.2023. The matter was considered by NRC in its 412th meeting held on 25th September 2023 and Committee decided to withdraw the recognition of M.Ed. Course under section 17 of NCTE Act, 1993 from the academic session 2024-2025 on the following grounds: -
 - > The institution has not submitted certified land documents issued by Govt. Competent Authority.
 - > The institution has submitted building plan but not approved by the Govt. Competent Authority and not mentioned earmarked area for each course being run in the same premises.
 - > The institution has not submitted land use certificate issued by the Govt. Competent Authority.
 - > The institution has not submitted latest Non Encumbrance Certificate issued by Govt. Competent Authority.

- > The institution has submitted Building Completion Certificate but not issued by the Govt. Competent Authority.
- The institution has not submitted details of salary disbursed to the faculty along with a six-month Bank statement and Account number of each faculty member.
- The institution has submitted approval letter only six Assistant Professor. The institution has not appointed two Professors & two Associate Professor.
- The institution has not adhered to the mandatory disclosure in the prescribed format and displays up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.

Accordingly, Withdrawal Order was issued to the institution on 07/10/2023.

6. **AND WHEREAS**, the institution preferred an appeal before NCTE (HQ) under Section 18 of NCTE Act, 1993. The Appellate Authority passed an Order No. File No. 89-215/E-322070/2023 Appeal/15th Meeting, 2023 APPLNRC202314636/123206 dated: 19/12/2023 as under: -

IV DECISION: -

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing Appeal Committee of the council concluded to remand back the case to NRC with a direction to verify the submitted documents filed by the appellant institution with appeal from the records available with NRC and if it feel necessary and appropriate then documents may also be verified from the concerned competent authority. The appellant institution is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of the appeal and after receipt of the same the NRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time in terms of direction given herein above.

7. AND WHEREAS, the representation from the institution received in NRC office on 28.12.2023 was considered by NRC in its 418th meeting held on 23rd and 24th January 2024 and Committee decided as under:

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time the NRC after careful consideration made the following observations: -

• The reply submitted by the institution vide letter dated 28.12.2023 with reference to the directions of Appeal Committee vide order dated 19.12.2023, the Committee observed that the institution submitted documents as per provision of the NCTE Regulations, 2014 and found the same satisfactory.

Hence the Committee decided that the status quo of the institution be maintained, and recognition granted to M.Ed. (one unit) is hereby continued."



8. NOW THEREFORE, the status quo of the institution i.e. Jawahar Lal Nehru Smarak Post Graduate College, Maharajganj, Janpad, Maharajganj – 273303, Uttar Pradesh be maintained, and recognition granted to M.Ed. course (one unit) is hereby continued.
