WHEREAS, recognition was granted by the Northern Regional Committee to Raksha Devi Uchchatar Madhyamik Vidhyalaya, Plot No.-760, Street/Road- Lodhinagar, Village-Khimsepur, Post Office- Khimsepur, Tehsil- Sadar, District- Farrukhabad – 209625, Uttar Pradesh NRC/NCTE/NRCAPP-14416/Recognition/D.El.Ed./2016/146821-7694 dated 02.05.2016 with an intake of 100 Students. (2 Units of 50 students each).

- 2. **AND, WHEREAS,** a Complaint dated 24.08.2017 was received from Shri Amar K. Singh against the above institution alleging that the institution does not have any UG course for affiliation of D.El.Ed. course.
- 3. **AND, WHEREAS,** the matter was considered by NRC in its Emergent meeting and 275th Meeting (Part-1) of the NRC held on 16th to 18th and 19th to 21st September, 2017 and the Committee decided as under:
 - a) The Committee decided that a copy of the complaint be forwarded to the institution for its Para-wise comment.
- 4. **AND, WHEREAS,** The matter was considered by NRC in its 281st meeting held on 20th to 21st February, 2018 and the Committee decided to issue Show Cause Notice U/S 17 to the institution on the following grounds:
 - a) A complaint was received in the NRC office. Accordingly, NRC decided for seeking Parawise comments from the institution in its 275th Meeting. Letter dt. 27.09.2017 was issued. The institution has not submitted reply of the letter till date.
- 5. **AND, WHEREAS,** the show cause notice U/s 17 was issued on 23.02.2018.
- 6. **AND, WHEREAS,** the institution did not submit reply of show cause notice U/s 17.
- 7. **AND, WHEREAS,** The matter was considered by NRC in its 303rd meeting held on 10th to 12th July, 2019 and the Committee decided to issue Second Show Cause Notice U/S 17 to the institution on the following grounds:
 - b) As per the Standard Operating Procedures issued by NCTE vide letter No. NCTE-CDN016(13)/2019-CDN-HQ dated 12th April, 2019, another opportunity can be given to an institution in case first SCN u/s 17 has not elicited any response or a partial response.

- 8. **AND, WHEREAS,** the second, show cause notice U/s 17 was issued on 02.08.2019.
- 9. AND, WHEREAS, the institution did not submit reply of second show cause notice U/s 17.
- 10. **AND, WHEREAS,** the matter was considered by the NRC in its 313th (Part-1) Meeting held from 25th to 27th February, 2020 and the Committee decided as under:-
 - As per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition of the institution may be withdrawn as enough opportunities have been given to the institution.

Hence, NRC decided to withdraw the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. A detailed withdrawal order be issued to the college.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of Raksha Devi Uchchatar Madhyamik Vidhyalaya, Plot No.-760, Street/Road- Lodhinagar, Village- Khimsepur, Post Office- Khimsepur, Tehsil- Sadar, District- Farrukhabad – 209625, Uttar Pradesh granted for D.El..Ed. course on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.
