WITHDRAWAL ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Sitapur Shiksha Sansthan, Plot/Khasra No. – 475, Street No. – Ramkot Road, Village/Town – Resaura, Post Office – Resaura, Tehsil/Taluka – Sitapur, Town City – Sitapur, District – Sitapur, Pin Code – 261001, State – Uttar Pradesh vide Order No. NRC/NCTE/F-7/UP-3044/147th Meeting/2009/8603 dated 21.08.2009 for B.Ed. course of one year duration with an annual intake of 100 seats from the academic session 2009-10. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-3044/2015/13631-37 dated 06.06.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 student each was issued to the institution with certain conditions.

- 2. **AND, WHEREAS,** the institution has not submitted documents/reply in compliance of the revised recognition order.
- 3. **AND, WHEREAS,** the matter was placed the Northern Regional Committee in its 281st Meeting held from 20th to 21st February, 2018. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order.

Accordingly, Show Cause Notice dated 04.04.2018 was issued to the institution.

- 4. **AND, WHEREAS,** the institution has submitted reply in NRC office on 24.04.2018/04.05.2018. as per decision of the NRC in its 308th Meeting held on 25th to 27th September, 2019, a show cause notice u/s 17 was issued to the institution on 15.10.2019 on following grounds: -
 - The institution has submitted the approved Building plan signed by the Competent Govt. Authority, however, the details with regard to the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc., have not been indicated thereon.
 - Original FDRs of Rs. Seven Lakh and Five Lakh of nationalized bank towards Endowment fund and Reserved Fund respectively is required.
 - The institution has not submitted the Non-Encumbrance Certificate issued by the Competent Authority indicating that the land is free from all encumbrances.

- The institution has not submitted the Building Completion Certificate signed by the Competent Government Authority.
- The institution has submitted approved teaching faculty list, which is less then for two units as per Regulations, 2014.
- The detail of qualifications of the faculty is not provided with the reply.
- 5. **AND, WHEREAS,** the institution has submitted reply in NRC office by E-mail and Hard Copy on 14.11.2019 and 15.11.2019. The matter was considered by the NRC in its 313th (Part-1) Meeting held from 25th to 27th February, 2020 and the Committee decided as under: -
 - As per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition
 of the institution may be withdrawn as enough opportunities have been given to the
 institution.

Hence, NRC decided to withdraw the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. A detailed withdrawal order be issued to the college.

6. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of Sitapur Shiksha Sansthan, Plot/Khasra No. – 475, Street No. – Ramkot Road, Village/Town – Resaura, Post Office – Resaura, Tehsil/Taluka – Sitapur, Town City – Sitapur, District – Sitapur, Pin Code – 261001, State – Uttar Pradesh granted for B.Ed. course for an intake of 100 seats on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.
