RESTORATION ORDER

WHEREAS, the recognition was granted to the institution namely Smt. Gomti Smarak Vigyan Mahavidyalaya, Nawab Nagar, Parson, District-Etah, Pin code-207001, Uttar **Pradesh** for offering **B.Ed.** course of one year duration with annual intake of 100 (One Hundred) students vide order No. F. No. F-3/UP-515/2002/9914 dated 10.01.2003 followed by revised recognition order for B.Ed. course of two year duration with an annual intake of 100 students i.e. two basic units of 50 students each vide order No. F.NO./NRC/NCTE/UP-515/2015/111620-26 dated 05.06.2015.

- AND WHEREAS, as per decision of NRC in its 313th Meeting held on 25th & 27th February 2020, withdrawal order for offering B.Ed. course was issued to the institution on 10.07.2020.
- 3. AND WHEREAS, the institution had filed W.P. (C) 10934/2021 before the High Court of Delhi. The Hon'ble High Court passed an order dated 27.09.2021 as under:-
 - 8. The present writ petition is, therefore, disposed of by clarifying that the impugned withdrawal order dated 10.07.2020 stands quashed by reason of the order of the Appellate Committee dated 20.11.2020. The petitioner will be permitted to participate in counselling and admit students for the year 2021-22 and for subsequent years, until and unless a fresh withdrawal order is passed against it. The respondents are directed to restore the status of the petitioner as a recognised institution and make necessary modifications on their website, as well as communicate the revised status of the petitioner to the authorities of the State Government and the affiliating University.
 - 9. Pending application also stands disposed of.
- **AND WHEREAS**, the matter was placed before NRC in its 365th (Part-2) (Blended Mode) 4. meeting held on 08th 09th March, 2022 and the Committee decided as under:-

"The Committee decided to withdraw the recognition in the 313th Meeting of the NRC held on 25th & 27th February, 2020.

(C) 10934/2021, the Committee has permitted the institution to take participate in the counselling session for admitting students for the session 2021-22.

As per appeal order 89-187E-165055/2020Appeal/23rd Mtg-2020/22nd October 2021 the order issued by NRC for withdrawal remanded back the matter with direction to the institution submit the complete compliance to NRC within 15 days.

The Committee has gone through the documents submitted by the institution is still deficient on the following points:-

- 1. The institution has not submitted latest approved faculty list.
- 2. The institution has submitted the last six-month salary statement of the faculty members with details of the account number but the statement is of 13 faculty members only that is upto March 2021.
- 3. The faculty list uploaded on the website of the college also is not matching with the list submitted.
- 4. The website is also not updated.

Hence, the Committee decided the withdrawal order be issued to the institution from the session 2022-2023.

- 5. AND WHEREAS, withdrawal order was issued to the institution on 08.04.2022.
- **6. AND WHEREAS,** the institution had preferred an appeal u/s 18 of the NCTE Act 1993 before the Council Delhi. The Appellate Authority passed an Order No. 89-251/E-277976/2022 Appeal/11th Meeting,2022/116576 dated 11.01.2023 as under:-

After perusal of the Memoranda of Appeal, affidavit documents on record and oral arguments advanced during the online hearing. Appeal Committee of the Council concluded that the NRC was justified in withdrawing the recognition and decided that the instant appeal deserves to be rejected and therefore, the impugned withdrawal order dated 08.04.2022 issued by NRC is confirmed.

- 7. **AND WHEREAS,** the Appellate Authority further noted that the petitioner institution had filed a W.P. (c) 3347/2023 before the Hon'ble High Court of Delhi at New Delhi against the Appeal Order dated 11.01.2023 i.e. rejecting the appeal of the appellant institution. The Hon'ble High court had passed an order dated 27.07.2023 to consider the same and decide the appeal afresh within a period of 30 days from the date of receipt of the representation.
- **8. AND WHEREAS,** after that Appellate Authority had passed an order No. 89-251/E277976/2023 Appeal/3rd Meeting, 2024/APPLNRC202214474/124229 dated 27.02.2024. The operative part of appeal order is as under:-

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to NRC with a direction to verify the faculty list submitted in appeal form the concerned Affiliating University and also at is liberty to verify other documents form the concerned competent authority. The Appellant institution is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of he Appeal and after receipt of the same the NRC to take further necessary action as per the NCTE Regulation, 2014 guidelines and amendments issued from time to time as per direction given herein above.

9. **AND WHEREAS**, the matter was placed before NRC in its 428th meeting held on 18th October, 2024 and the Committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following:-

- 1. The recognition of the institution was withdrawn vide order dated 08.04.2022.
- 2. The institution had filed an appeal before the Appellate Authority of the Council under section 18 of the NCTE Act, 1993 against the withdrawal order dated 08.04.2022 passed by the Northern Regional Committee (NRC).
- 3. The Appellate Authority vide its order dated 27.02.2024 remanded back the case to NRC with a direction to verify the faculty list submitted in appeal from the concerned Affiliating University and also at is liberty to verify other documents from the concerned competent authority and the Appellant institution was directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of the order of the Appeal.
- 4. In compliance of appeal order, the institution has submitted documents and the same have been received in the office of NRC on 26.04.2024 which is after lapse of 15 days as directed by the Appeal Committee.
- 5. The institution has also filed W.P. No. 12008/2024 before the Hon'ble High Court of Delhi and Hon'ble High Court has passed order dated 30.08.2024 in the said petition thereby directing NRC to file short reply.

In compliance of the order passed by the Appellate Authority dated 27.02.2024, the NRC examined the documents submitted by the institution and found the reply of the institution deficient on the following grounds: -

1. The institution has submitted photocopy list of faculty members dated 05.02.2024 i.e. of one HOD + 15 teaching staff which is approved Registrar Raja Mahinder Pratap Singh University, Aligarh, Uttar Pradesh. However, the institution is required to submit original faculty list duly approved by the affiliating university.

- 2. The institution has not submitted the letter from the affiliating body for approval of the faculty list.
- 3. The institution has not submitted downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.

Hence the Committee decided that a SCN be issued to the institution to submit reply within 21 days".

Accordingly, show cause notice was issued to the institution on 07.11.2024. The institution had submitted reply of show cause notice vide letter dated 24.11.2024 received in NRC office vide E-receipt No. 351749 dated 10.12.2024.

10. AND WHEREAS, the matter was placed before NRC in its 444th Meeting (Volume-1) held on 24th & 25th July, 2025 and the Committee decided as under:-

"Decision of NRC in compliance of the Court Order W.P. (C) 12008/2024 dated 23.07.2025. Hon'ble High Court of Delhi while hearing to the W.P. (C) No. 12008/2024 on 23.07.2025, titled Smt. Gomti Smarak Vigyan Mahavidyalaya versus National Council for Teacher Education & Anr disposed of the Writ Petition with the following directions to NRC on the following:-

- 1. NRC is directed to pass an order of restoration in favour of petitioner institution for recognition of the concerned course in accordance with law within a period of 10 days from 23.07.2025.
- 2. The said order shall remain subject to a further decision to be taken by NRC. A copy of the order of restoration of recognition of petitioner institution for the concerned course will be communicated to all concerned. Once the order of restoration is passed, the petitioner institution will be entitled to participate in counseling and admission process for the Academic years 2025-26 and subsequent academic sessions. The NRC is directed to update its website accordingly.

In view of the direction of the Hon'ble High Court of Delhi, the Committee decided to restore the recognition of the institution for conducting B.Ed. course of two year duration with an annual intake of 100 students (two units). However, the original file of the institution along other related documents NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time and reply of the Show Cause Notice received from the institution were placed before the Northern Regional Committee and the Committee observed the following institution:-

- 1. The recognition was granted to the institution namely Smt. Gomti Smarak Vigyan Mahavidyalaya, Nawab Nagar, Parson, District-Etah, Pin Code-207001, State-Uttar Pradesh for B.Ed. one year duration with an annual intake of 100 students vide order no. NRC/NCTE/F-3/UP-515/2002/9914 dated 10.01.2023.
- 2. The recognition of the institution was withdrawn vide order dated 08.04.2022.
- 3. The institution had filed an appeal before the Appellate Authority of the Council under Section 18 of the NCTE Act, 1993 against the withdrawal order dated 08.04.2022 passed by the Northern Reginal Committee (NRC).
- 4. The Appellate Authority vide its order dated 27.02.2024 remanded back the case to NRC with a direction to verify the faculty list submitted in appeal from documents from the concerned competent authority and the Appellant institution was directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of the order of the Appeal.
- 5. In compliance of appeal order, the institution has submitted documents and the same have been received in the office of NRC on 26.04.2024 which is after lapse of 15 days as directed by the Appeal Committee.
- 6. The institution has also filed W.P. No. 12008/2024 before the Hon'ble High Court of Delhi and Hon'ble High Court has passed order dated 30.08.2024 in the said petition thereby directing NRC to file short reply.
- 7. A show cause notice was issued to the institution on 07/11/2024. The institution has submitted reply of show cause notice vide letter dated 24.11.2024 received in NRC office E-receipt no. 351749 dated 10.12.2024.
- 8. The Committee considered the reply dated 12/04/2025 received in NRC on 10/06/2025 and found the following deficiencies.
- i. The institution has submitted photocopy list of faculty members teaching staff, which is approved by the Registrar Raja Mahinder Pratap Singh University, Aligarh, Uttar Pradesh. However, the institution is required to submit original faculty list duly approved by the affiliating University. This letter should have been issued in the last quarter, accompanied by the bank statement reflecting the salary disbursed to the faculty of the aforementioned programme.
- ii. The institution has not submitted the letter from the affiliating body for approval of the faculty list.
- iii. The institution has not submitted the relevant documents for change in the affiliating body along with other necessary documents including a no-objection certificate from Dr. Bhim Rao Ambedkar University, Agra to the Raja Mahinder Pratap Singh University, Aligarh, Uttar Pradesh.

iv. The institution has not submitted downloaded copies of document from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.

Accordingly, a final opportunity be also provided to the institution and a show cause notice be issued to the institution on the aforesaid grounds.
