WHEREAS, the institution, namely, Vindhya Gurukul College, Plot No. - 9, Street No. - 0, Village - Gosaipur, Post Office - Shahpur Chunar Tehsil/Taluka- Chunar, Town/City - Mirzapur, District - Mirzapur, State - Uttar Pradesh -231304 was granted recognition for B.Ed. course with an annual intake of 50 students (1 unit) vide order No. NRC/NCTE/NRCAPP-15386/266th meeting (Part-2)/ B.Ed./2017/171403-09 dated 17th April, 2017 and for D.El.Ed. course with an annual intake of 100 students (2units) vide order No. NRC/NCTE/NRCAPP-15425/266th meeting (Part-2)/ D.El.Ed./2017/171396-402 dated 17th April, 2017 and was issued Letter of Intent for B.A. B.Ed./B.Sc. B.Ed. course vide letter No. F. NRC/ NCTE/NRCAPP-15290/273rd Meeting (Part-2)/2017/180395-97/ dated 18th August, 2017.

AND WHEREAS, the institution submitted an application dated 12.09.2017 to the NRC-NCTE received on 14.09.2017, requesting for change of name of the institution from Vindhya Gurukul College to Vindhya Gurukul College for Women for conducting the above courses.

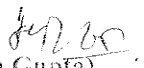
AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its Emergent and 275th meeting held from 16th to 21st September, 2017 considered the case of the institution under provisions of the NCTE Act, Regulations and Guidelines issued by NCTE-Hqrs. and decided as under: -

- The request of the institution has been considered in the light of NCTE (HQ) letter No. F.No.49-3/2016/NCTE/N&S/47143 dated 08.12.2016 which *inter-alia* provides that "With respect to change of name of the institution, this may be permitted if the land is not transferred to the existing institution proposed to be changed. If the land is already transferred from Society to the institution or if the land is the name of the institution any change in the name of institution shall essentially require change in the ownership of the land. In this case processing fees may be charged for inspection process."

In the instant this, since the land is in the name of the sponsoring Society, the NRC decided that the institution may be permitted to change its name as Vindhya Gurukul College for Women.

NOW THEREFORE, the Northern, Regional Committee hereby grants permission to the institution for change of its name from Vindhya Gurukul College to Vindhya Gurukul College for Women.

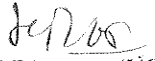
