In order to implement the NCTE Regulations, 2014, all the existing TEIs running B.Ed. course were allowed either to have 2 or more units or to have one unit only from the Academic Session 2015-16. The TEIs which opted for two or more units of B.Ed. were required to appoint additional faculty & staff by 29.02.2016 and to provide the additional infrastructure as required under NCTE Regulations, 2014 prior to

31.10.2015 which was later on extended up to 30.05.2016.

In case of B.P.Ed., the intake has been increased to 100 students (one unit) from the existing 100 and in case of M.Ed. to 50(one unit) from the existing 50 students subject to appointment of additional faculty & staff by 29.02.2016 and to provide the additional infrastructure as required under NCTE Regulations, 2014 prior to 31.10.2015 which was later on extended up to 30.05.2016.

The NCTE Hqrs., New Delhi vide its letter No.48-11/2016/N&S/28811 dated 17.05.2016 has directed the ERC to initiate the process of monitoring the existing TEIs in compliance of the provisions of NCTE Regulations, 2014. The defaulting TEI's need to be asked to submit the necessary documents alng with the documents related to additional Faculty/Staff through the concerned affiliating university, to the Regional Committee and on the basis of these documents, the intake capacity of the TEI's may be determined afresh. If felt necessary, an inspection of the institutions may also be conducted for this purpose.

The ERC considered the matter in detail and decided as under:

Keeping in view the judgement of Hon'ble Supereme Court of India in the case of Vaishnav Insitute of Technology and Management V/s NCTE & others (Civil Appeal No. 3505 of 2012), a clarification may be sought from the NCTE Hqrs under which provision (Section 13 or Section 17 of NCTE Act 1993) inspection of the aforesaid institutions is to be conducted by ERC, NCTE, Bhubaneswar.

 - (i) As per old CD, only one building was reflected and visited by the VT experts.
 - (i) As per fresh CD, an another building was reflected which was not visited by the VT experts and this building seems to be a very old one and under construction. At a glance existence of two buildings (five storied) are not reflected which concludes that both the buildings do not exist in the same plots and same boundary of the institution.

In view the above, the committee decided as under:

The committee is of the opinion that application bearing code No.ERCAPP3549 of the institution regarding recognition for B.Ed. Programme is refused under section 14(3)(b) of NCTE Act 1993.
