The minutes of the 312th (Emergent) meeting were read and confirmed. The Committee expressed its disaffection regarding timely processing/challenging (as the case may be) the orders received from various courts of law. It was brought to the notice of the Committee that the necessary instructions have been issued by RD, NRC in this regard time and again. The judgements passed in the matter of Sir Chhotu Ram Jat College of Education and Saraswati Deep College of Education were placed before the Committee with a request to comply the same. The Committee decided to comply these orders and decided that the cases related to the Sir Chhotu Ram Jat College of Education are subject to the outcome of LPA filed in the matter. Further, in view of the college related to the judgement passed in Saraswati Deep College of Education, the Committee decided that in compliance of the court directions, an opportunity of personal hearing is to be given to the authorized representatives of the colleges/petitioners. However, NRC has received no such request from the colleges therefore the petitioners may be informed that next date of meeting.
