**CIRCULAR**

This is with reference to the Public Notice dated 25.03.2026 appointing Nodal Officers for each of the four Regional Committees to assist the Teacher Education Institutions (TEIs) in updating contact details and resolving portal-related technical issues on the ICUP portal and another Public Notice dated 05.05.2026 reopening the online PAR portal for a final, one-time opportunity issued by NCTE.

2. The Hon'ble High Court of Delhi at New Delhi in W.P. (C) No. 7347/2026 & CM APPL. 35836/2026 titled *Shree Uday Trust & Others Vs. NCTE & ANR*. has *inter alia* passed an Order dated 29.05.2026 as under:

- i. Each Regional Committee will appoint a nodal officer whose name, email and mobile number shall be displayed on the official website of the respondent No. 1 on or before 02.06.2026.
- ii. The petitioners and other similarly situated institutes having issues with regard to their contact details having not been updated will contact the nodal officer who shall facilitate the same expeditiously in order to meet the timelines.
- iii. The nodal officer shall remain available from 10:00 am to 5:00 pm on every working day.

2. The following Nodal Officers were appointed vide Public Notice dated 25.03.2026 for each of the four Regional Committees to resolve portal-related technical issues.
