**PUBLIC NOTICE**

The National Council for Teacher Education is a statutory body that came into existence in pursuance of the National Council for Teacher Education Act, 1993 (No. 73 of 1993) on 17th August 1995 to achieve the planned and coordinated development of teacher education system throughout the country, the regulation and proper maintenance of norms and standards in teacher education system and for matters connected therewith.

2. The General Body of the NCTE in its 68th (Emergent) Meeting held on 25.11.2025 has approved the reopening of the online Performance Appraisal Reporting (PAR) portal as a final, one-time opportunity for submission of PAR for the academic session 2021-2022 and 2022-2023 by the Teacher Education Institutions (TEIs).

3. Subsequently, in compliance of Order dated 15.12.2025 of the Hon'ble High Court of Delhi in WP. (C) No. 5369/2025 and subsequent orders in similar matters, three weeks' time from 27.03.2026 to 16.04.2026 was provided vide NCTE Public Notice dated 25.03.2026 to update mobile numbers and email IDs on the Institute Contact Update Portal available on the NCTE website to those TEIs whose recognition status has been restored on the basis of an Order of Competent Authority.

4. In further compliance, **six weeks' time from 07.05.2026 to 17.06.02026 (till 11:59 pm) is hereby given for submission of PAR for the Academic Session(s) 2021-2022 and 2022-2023** to following TEIs:

- a. TEIs whose recognition status is active or whose recognition status has been restored on the basis of an order of competent legal authority.
- b. TEIs who have already submitted their PAR but wish to update or revise their data shall be allowed to do so without payment of any additional fee. It shall be option of the TEIs to submit any further particulars of their PAR in addition to the PAR details which have already been uploaded.
- c. TEIs which were recognized but were not affiliated by the concerned affiliating body need not submit PAR for the years for which they were not so affiliated.

5. The Council has approved the reopening of the online PAR portal for a final, one-time opportunity and the scope of submission is structured as follows:

- o TEIs recognized up to Academic Session 2021-22: Must submit PAR for both 2021-22 and 2022-23.
- o TEIs recognized in Academic Session 2022-23: Must submit PAR for 2022-23 only.

- TEIs recognized in/after 2023-24: Are not required to submit PAR for this specific cycle.
6. The Council has approved the following fee structure for this window:
- **New Submission:** TEIs submitting PAR for the first time shall pay the processing fee as prescribed in the 2024 Public Notice (i.e. Rs. 15,000/- + GST for Private TEIs and Rs. 5000/- + GST for Government TEIs, per academic session).
  - **Resubmission/Revision:** TEIs which have already submitted their PAR but wish to update or revise their data, shall be allowed to do so without payment of any additional fee.
8. The Council has emphasized that the submission of PAR is mandatory for the continuation of recognition and any TEI that fails to submit PAR within this final stipulated window shall be liable for appropriate action being instituted against it in terms of Section 17 of the NCTE Act, 1993, including withdrawal of its recognition.
