WHEREAS, the recognition was granted to the institution namely, Prof. S.A. Teacher Training Institute, 1/93 Sardar Patel Road, Prof. Syed Ameeruddin Avenue, Chemencherry, Chennai, Tamilnadu-600014 run by Prof. Syed Ameeruddin Educational Trust vide SRC vide order no. F.TN/913/SRO/NCTE/2004-05/6811 dt. 13.09.2004 for conducting Elementary course of two years duration from the academic session 2004-2005.

2. AND WHEREAS, the institution vide letter dated 06.12.2021 has submitted request to close the D.T.Ed. Programme. The SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December 2021 considered the request for close the D.T.Ed. Programme matter and decided as under:

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the society vide letter dated 06.12.2021 by withdrawing the recognition granted to **Prof. S.A. Teacher Training Institute**, 1/93 Sardar Patel Road, Prof. Syed Ameeruddin Avenue, Chemencherry, Chennai, Tamilnadu-600014 for conducting D.T.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

- 3. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Prof. S.A. Teacher Training Institute, 1/93 Sardar Patel Road, Prof. Syed Ameeruddin Avenue, Chemencherry, Chennai, Tamilnadu-600014 run by Prof. Syed Ameeruddin Educational Trust, Tamilnadu for conducting D.T.Ed. Programme for 50 students with effect from the academic session i.e., 2022-2023 onwards.
- **4.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central
