WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **Smt. Addepalli Mahalakshmi Devi College of Education for Women, Door No.46-B-14, Danavaipeta, Rajahumadry-533103, East Godavari District, Andhra Pradesh** vide SRC (NCTE) order No. F.SRO/NCTE/APS04268/B.Ed./2004-2005/1505 dated 21.06.2005 for an additional intake of 40 students in B.Ed. course of one year duration from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 (two basic units 50 students each) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC issued a Corrigendum vide Order No.F.SRO/NCTE/APS0 8976/B.Ed./AP/2015/69678 to the institution on 10.07.2015 **200 students four basic units.**

4. **AND WHEREAS**, the matter was placed before the Southern Regional Committee in its 369th meeting held on 28.01.2019. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order. Accordingly, as per the decision of SRC show cause notice was issued to the institution on 05.02.2019. The institution vide dated 12.03.2019 submitted reply in response to the Show Cause Notice.

5. **AND WHEREAS**, the matter was further considered by the SRC in its meeting 393rd held on 05th & 16th January, 2021 and the committee decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC final show cause notice was issued to the institution on 11.01.2021. The institution has submitted reply of Final Show Cause Notice on 24.02.2021 & 02.03.2021.

6. **AND WHEREAS**, the matter was further considered by the SRC in its 405th meeting held on 13th – 14th December, 2021 and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 24.02.2021 & 02.03.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution has submitted notarized photocopy of building plan in which survey nos, multipurpose hall etc. have not been mentioned. Further, the approving authority is not clear.
2. The institution had submitted photocopy of building completion certificate but the same is not approved by the competent authority.
3. The institution had submitted faculty 1+8 for B.Ed. course (200 students; four units) against the requirement of 1+27 as per NCTE Regulations, 2014. The faculty strength is not enough to run B.Ed. course with four units.
4. The institution had submitted form 'A' issued by the concerned bank regarding FDRs of Rs. 7 and 3 lakhs (total 10 lakh) against the requirement of 7 + 5 lakh (12 lakhs) towards Endowment and Reserve Funds. Accordingly, the institution is not maintaining Endowment and Reserve Funds with sufficient amount as required under NCTE Regulations, 2014.
5. The institution did not submit details of administrative and professional staff as required under clause 5.3 of Appendix 4 of NCTE Regulations, 2014 for B.Ed. course.
6. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
7. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to **withdraw the recognition** granted to **Smt. Addepalli Mahalakshmi Devi College of Education for Women, Door No.46-B-14, Danavaipeta, Rajahmundry-533103, East Godavari District, Andhra Pradesh** for conducting **B.Ed. (4 units)** programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

7. **NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Addepalli Mahalakshmi Devi College of Education for Women, Door No.46-B-14, Danavaipeta, Rajahmundry-533103, East Godavari District, Andhra Pradesh** for conducting **B.Ed.** programme of two year duration with an annual intake of 200 students (four basic units) for B.Ed. course with effect from the academic session i.e. 2022-2023 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
