WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **B.A & K.R. College of Teacher Education, Medaramelta (Village), Korisapadu (Mandal), Prakasam District-523212, Andhra Pradesh** run by **Sri Sai Priyadarshini Educational Society, Prakasam District, Andhra Pradesh** vide SRC (NCTE) order No. F.SRO/NCTE/2007-2008/10933 dated 01.09.2007 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 13.01.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units 50 students each) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28th January 2019 considered the matter and committee decided to issue show cause notice. Accordingly, Show Cause Notice Issued to institution on 15.02.2019. The institution has not submitted reply Show Cause Notice.

AND WHEREAS, the SRC in its 388th meeting held on 14th – 15th September 2020 considered the matter and committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice Issued to institution on 13.07. 2021. The institution has not submitted reply of Final Show Cause Notice.

AND WHEREAS, the decision for withdrawal of recognition for B.Ed. programme w.e. from the academic session 2021-2022 taken in 404th meeting held on 16th 17th November during has been placed before SRC Meeting held on 405th on 13th 14th December 2021 for review committee has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice on 12.07.2021. The institution failed to submit reply to the Final Show Cause Notice (FSCN).

*Hence, the Committee decided to **withdraw the recognition** granted to **B.A & K.R. College of Teacher Education, Medarameltla (Village), Korisapadu (Mandal), Prakasam District-523212, Andhra Pradesh** for conducting **B.Ed. programme** with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **B.A & K.R. College of Teacher Education, Medarameltla (Village), Korisapadu (Mandal), Prakasam District-523212, Andhra Pradesh** for conducting **B.Ed. programme** of two year duration with an annual intake of 100 students (two basic units) for B.Ed. course with effect from the academic session i.e. 2022-2023 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
