WHEREAS, the recognition was granted to the institution namely Al-Madina College of Education, No. 2-1/1, Keshawahpally Village, Thipparty Mandal, Nalgonda-508001, Telangana run by Al Madeena Educational Society, Nalgonda vide SRC (NCTE) order No. F.SRO/NCTE/B.Ed/2011/28075 dated 11.04.2011 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2011-2012.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.02.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 19.03.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units 50 students each) from the academic session 2015-16.

AND WHEREAS, the institution has submitted request for reduction of intake from 2 units to 1 unit on dated 02.03.16. accordingly, a corrigendum order no. SRO/NCTE/APS09727/B.Ed./TS/2017-18/94085 dated 21.07.2017 was issued to the institution for conducting B.Ed. programme of two-years duration with an annual intake of 50 for one basic unit of 50 students.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice was issued to the institution on 26.02.2019.the institution has submitted on 01.04.2019 its reply to the Show Cause Notice.

AND WHEREAS, the SRC in its 377th Meeting held on 03rd & 04th July, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 17.07.2019. The institution has submitted reply on 30.12.2019. The institutions vide letter dated 25.07.2019 & 16.11.2019 submitted reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 389th Meeting held on 12th & 14th October 2020 considered the matter and decided to issue Last Reminder Letter. Accordingly, as per decision a Last Reminder Letter was issued to the institution on 16.10.2020. The institution has submitted reply of Last Reminder Letter on 04.12.2020

AND WHEREAS, the SRC in its 405th meeting held during 13th – 14th December 2021 considered the matter and decided as under:-

Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Last Reminder Letter. The institution has submitted its reply vide letter dated 04.12.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted faculty approval letter dated 19.12.2019. The institution has not submitted latest faculty list duly approved by Affiliating University in prescribed format as per NCTE Regulation 2014.
- 2. The institution did not submit proforma of faculty inter-alia mentioning the qualification and date of joining of all faculty duly approved by the affiliating body.
- 3. All 14 staff have been shown as "renewal" in letter dt. 19.12.2019 whereas vide letters dt. 01.03.2016 and 12.12.2017 only 9 faculty have been shown as "renewal". The initial approval of 5 faculty have neither been submitted nor the institution had submitted their date of joining.
- 4. The building plan submitted by the instituitno do not show the total built up area of the institution.
- 5. As per Visiting Team Report and building plan submitted at the time of recognition, the built up area at first floor is shown as 521.05 sq.mtrs. wheras the building plan submitted now is showing the size of first floor as 1277.26 sq.mtrs. which is totally different and the act of institution is treated as misleading to the SRC.
- 6. The website of the institution is not uploaded with the information required under clauses 7(14)(I), 8(14) and 10(3) of NCTE Regulations, 2014.
- 7. The Institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clauses 10(2) of NCTE Regulation, 2014.

Hence, the Committee decided to withdraw the recognition granted to Al-Madina College of Education, No. 2-1/1, Keshawahpally Village, Thipparty Mandal, Nalgonda-508001, Telangana for conducting B.Ed. programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Al-Madina College of Education, No. 2-1/1, Keshawahpally Village, Thipparty Mandal, Nalgonda-508001, Telangana for conducting B.Ed. programme of two year duration with an annual intake of 50 students (one basic unit) for B.Ed. course with effect from the academic session i.e. 2022-2023 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or

permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
