WHEREAS the Sai Ram College of Education, No.14A, Pidari West Street, Sirkali, Nagapattinam District-609110, Tamilnadu was granted recognition on 23.12.2005 for B.Ed. course with an annual intake of 100 students with a condition that the institution shall shift to its own premises/building within three years from the date of recognition (in case the course is started in a rented premises).

AND WHEREAS, the institution has submitted its willingness affidavit on 29.01.2015 as per regulations 2014. Accordingly, revised recognition order was issued to the institution on 13.05.2015 with a condition that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 23.12.2005.

AND WHEREAS, the institution has submitted its written representation on 29.07.2015 and the matter was considering by the SRC in 315th Meeting held on 17th & 18 June 2016 and it decided the following:

- 1. The Gift Deed for the land is clearly in favour of the Trust. The Shifting condition is, therefore removed.
- 2. EC is in order.
- 3. LUC is in order.
- 4. BP is not approved by competent authority.
- 5. BCC is not given.
- 6. Original FDRs and latest faculty list are not given.
- 7. Inspection fee is not paid.
- 8. Collect fee and cause inspection.
- 9. Ask VT to college all relevant documents; and check in particular adequacy of build-up area to accommodate B.Ed. (2 units) of the 2014 pattern ie., total intake of (100+100) = 200.

AND WHEREAS, a Letter was issued on 03.08.2016.

AND WHEREAS, the institution has paid a Fee of Rs 1,50,000/- on 01.09.2016 for inspection. The VT was conducted on 19.08.2016 and submitted its report on 22.08.2016.

AND WHEREAS, the above matter was placed before the SRC in its 387th Meeting held on 24th & 25th August 2020. The Committee considered the matter and decided to issue Final Show Cause Notice to submit the compliance to the conditions mentioned therein. Accordingly, a Final Show Cause Notice was issued on 01.09.2020.

AND WHEREAS, the institution has submitted its reply on 16.10.2020.

AND WHEREAS, the compliance submitted by the institution on dt. 17.03.2020 and the matter was considered by the SRC in its 390th Meeting held on 28th & 29th October 2020 as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 16.10.2020, the Committee decided that the continuation order be issued to the Institution Sai Ram College of Education, Nagapattinam District-609110, TamilNadu for B.Ed. programme for 2 basic units of 50 students each unit. The Committee also decided that the shifting of premises be permitted as the institution has shifted to its own permanent building and the inspection of new premise has already been conducted."

NOW THEREFORE, the SRC decided to permit the institution i.e. Sairam College of Education, no. 119/3, 131/1, 130/2, 133/2, 14A, Pidari West Street, Karaimedu Panchayat, Sirkali Taluk, Nagapattinam District, Tamilnadu-609110 for B.Ed. course run by Sairam Educational Trust, 41, Kamaraj Street, Sirkali, Nagapattinam District, Tamilnadu-609110 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

- 14. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 17. The institution shall make available the list of students admitted on its official website.
- 18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
