WHEREAS, the recognition was granted to the institution namely P.K.D College of Education, 30/12, Kullakkapalayam Pirivu Achipatti P.O. Mahalingapuram Via Pollachi 642002, Tamil Nadu run by P.K.D Trust, 30/12, Venkataraman Road, Mahalingapura, Pollachi 642002, Tamil Nadu on dt. 31.06.2006 for conducting D.T.Ed. course of two-years duration with an annual intake of 50 students.

AND WHEREAS, the matter was finally considered by the SRC in its 389th Virtual Meeting held from 12th & 14th October 2020 decided as under: -

> "The Committee decided to withdraw the recognition granted to P.K.D. College of Education, 30/12, Venkataraman Road, Mahalingapuram, Pollachi, Tamilnadu-642002 for conducting B.Ed & D.T.Ed courses under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 21.09.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course."

Hence, the Committee decided to withdraw the recognition granted to P.K.D College of Education, 30/12, Kullakkapalayam Pirivu Achipatti P.O. Mahalingapuram Via Pollachi 642002, Tamil Nadu run by P.K.D Trust, 30/12, Venkataraman Road, Mahalingapura, Pollachi 642002, Tamil Nadu for conducting D.T.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17 of 1993 of NCTE Regulations the institution namely P.K.D College of Education, 30/12, Kullakkapalayam Pirivu Achipatti P.O. Mahalingapuram Via Pollachi 642002, Tamil Nadu run by P.K.D Trust, 30/12, Venkataraman Road, Mahalingapura, Pollachi 642002, Tamil Nadu, is hereby withdrawn for conducting D.T.Ed programme of two years duration with an annual intake of 100 students on the grounds mentioned above. The withdrawal of recognition is effective from the academic session commences next to issuance of this order.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a>, with 60 days from the date of issue of this order.
