WITHDRAWAL ORDER

WHEREAS, the institution **Pallavan College of Education, Melmonavoor Village, Vellore Taluk, No.1, Bharathiyar Salai, Vellore-632010, Tamilnadu** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/10500 dated 03.02.2007 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 10.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, in the meantime, in 314th meeting held on 27th & 28th May 2016 the SRC taken general decision to cause inspection of such cases

AND WHEREAS, as per the decision of SRC, a letter for inspection was sent on 14.06.2016 but inspection was not conducted.

AND WHEREAS the matter was further considered by the Sub-committee constituted by the SRC as per its decision taken in 381st meeting held on 31st October – 01st November, 2019 and decided to issue First Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution.

AND WHEREAS, as per the decision a First Show Cause Notice was issued to the institution on 21.08.2020. The institution submitted its reply along with documents dt.14.09.2020.

AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October 2020 and considered the matter as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

"The institution was issued a Final Show Cause Notice (FSCN) dated 21.08.2020. The institution has submitted its reply on 14.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

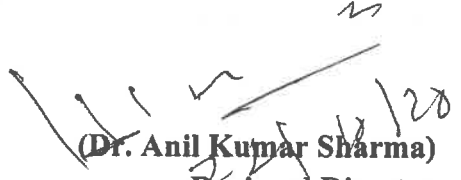
1. The institute did not submit notarized English translation of NEC.
2. The institution has submitted staff list of 1+10 against the requirement of 1+15 under NCTE Regulations 2014.
3. Faculty members namely Suresh Kumar V, Ramesh Pand Velu. S. are not qualified as having less than 55% marks in P.G.
4. Further, the institution did not submit 'Form A' and original FDRs towards Endowment and Reserve Funds."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to Pallavan College of Education, Melmonavoor Village, Vellore Taluk, No.1, Bharathiyar Salai, Vellore-632010, Tamilnadu for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
